#### **TRAIL CHAMPIONS**

#### Kristen Bennett - MTAC Resolution No. 4

Bob Wilson proposed recognizing Kristen Bennett, former working out of class DNR State Trails Coordinator, as a trail champion. Motion was made to approve the resolution by Richard Williamson and seconded by Mike Maves, with all in favor. Motion carried.

#### Jenny Cook - MTAC Resolution No. 5

Amy Scharmen-Burgdolf proposed recognizing Jenny Cook, Equine Trails Subcommittee (ETS) member, as a trail champion. Motion was made to approve the resolution by Richard Williamson and seconded by Mike Maves, with all in favor. Motion carried.

#### **EXPAND NONMOTORIZED USE IN STATE GAME AREA - MTAC RESOLUTION NO. 6**

Bob Wilson proposed that MTAC hereby resolves and urges the Department to explore all options for expanding nonmotorized uses on or in state game areas so that it takes full advantage of the flexibility of the Pittman Robertson Act and other state lands tied to federal funding sources, in terms of allowing for uses that are compatible with hunting and fishing and still remain in compliance with state and federal law. Motion made by Ken Hopper to approve the resolution and seconded by Richard Williamson, with all in favor. Motion carried.

#### PROPOSED MTAC RESTRUCTURE - MTACT RESOLUTION NO. 8

Jason Aric Jones proposed forming a workgroup to include various members of MTAC and its subcommittees to research, investigate, and recommend a restructure of the MTAC. No vote taken on resolution until all user groups can be represented within MTAC (noting vacancies for equestrians).

#### **MTAC VACANCIES**

Tim Novak, DNR, mentioned the two ETS vacancies should be filled soon. The Governor's office is working on the remaining open seats for ORV and snow.

#### **NORTH BANK TRAIL PROJECT - MTAC LETTER OF SUPPORT**

Kate Terpstra, from the city of Coopersville, has solicited MTAC for their support of the North Bank Trail connection project. Jason Aric Jones mentioned the request is missing elements and he would like to clarify the ask and trail details Ms. Terpstra before a letter of support is granted. Jenny Cook added she would like equestrians involved in the discussions. This item is to be moved to next MTAC meeting in December.

#### **UPDATES**

#### **USFS**

Andrew Kenyon provided updates from the U.S. Forest Services. For trail related updates, Andrew mentioned an ORV project in Alcona County, on the Huron side of National Forest just completed. The ORV project involved a trail reconstruction and bridge repairs. The U.S. Forest Service is working together with MSU for a capacity analysis on the Manistee River Loop, a nonmotorized trail, to study the amount of use and what improvements can be made to sustain the trail system. This trail has seen an increase of use over the past couple years. Oscoda and Huron Shores do not have a lot of mountain biking trails in the area and the forest service has been getting hammered with the public asking for mountain bike trail development. So, the forest service has partnered with local mountain bike groups. A grant was received from the National Forest Foundation and are in the development stage for what will be called the Wildcat Mountain Bike Trail, about a 14-mile trail system.

### Non-motorized Use in State Game Areas

The Michigan Trails Advisory Council hereby resolves and urges the Department to explore all options for expanding non-motorized uses on or in state game areas so that it takes full advantage of the flexibility of the Pittman Robertson Act and other state lands tied to federal funding sources, in terms of allowing for uses that are compatible with hunting and fishing and still remain in compliance with state and federal law.

There exist currently several examples where various non-motorized trail uses are specifically permitted in state game areas such as the Cannonsburg Game Area. The latest department outdoor recreation survey has indicated clearly that expanding non-motorized trail use is the greatest single recreation need for the people of Michigan.

The department should specifically explore what other states have been able to do with expanding non-motorized uses in game areas while remaining in compliance with state and federal law. MTAC specifically requests that a series of recommendations be made to council no later than December 31, 2022.

#### MTAC RESOLUTION 08-2022

#### MTAC Board Restructure

Whereas the Michigan Trails Advisory Council (MTAC) was originally enacted by the Michigan Legislature as a part of the Michigan Trailways Act to provide for a multi-member representative body that would advise the Michigan Department of Natural Resources (MDNR) and the governor on the creation, development, operation, and maintenance of motorized and nonmotorized trails in the state, including snowmobile, biking, equestrian, hiking, off-road vehicle and skiing trails; and,

Whereas the statute currently mandates that seven (7) of the MTAC seats to be representatives of the motorized trail community, and another two (2) to be mandated as representatives of the equestrian community; and,

Whereas the statute has no specific provisions regardingnonmotorized trail user representation from the biking, foot (hiking and trail running), skiing or water trails communities; and,

Whereas the statute leaves only two (2) seats for representation from all non-equestrian related non-motorized trail user groups; and,

Whereas the supporting subcommittees advising the MTAC also lack adequate representation with no specific workgroup representation from user groups such as bicyclists, foot users (hiking and trail running), skiers or water trail users; and,

Whereas the statute makes no differentiation between trail types and user needs other than to specify "motorized" and "non-motorized"; and,

Whereas during the twenty-nine (29) years since the MTAC was initially enacted there have been material changes in both the diversity of trail users and types of trails managed by the MDNR; and,

Whereas changes in technologies have had, and are continuing to have a profound effect on the ways users choose to interact with trails, and the way trails are being constructed; and,

Whereas trails are repeatedly cited as desired recreational infrastructure sought after by both tourists and local residents in our state; and,

Whereas recreational trails have a profound impact on the health and sustainable growth of the Michigan economy; and,

Whereas, it is the statutory charge of the MTAC to appropriately represent the demands of changing trail user demographics and to ensure the inventory of State trails is appropriately addressing those demands; and,

Whereas it is the responsibility of the members of MTAC to represent the collective recreational desires and needs of Michigan citizens to state government; and,

Whereas it is crucial for the MDNR to remain proactive regarding future outdoor recreational needs and use shifts, as expressed by the citizens and businesses of the State;

**NOW THEREFORE, BE IT RESOLVED** that the members of the MTAC are requesting that the MDNR take the steps necessary to form and support the efforts of a workgroup with various members of MTAC and its subcommittees, and to gather input from public trails stakeholder groups and users, to address and make specific recommendations for a proposed restructuring of the composition of the membership of MTAC, with those recommended presented to MTAC not later than January 31, 2023.

The Equine Friends of Berrien County Trails volunteer group promoted awareness of the Friends of Berrien County Trails Master Plan at the Berrien County Youth Fair. They also and featured the ELRC National Safe Trail Passing Plan for bikers/hikers/equestrians for Michigan trail riding opportunities, and a survey which asked: "Would you support (safe off road) Berrien County equestrian trails?" and "Would you be willing to share a trail with horse riders?" - 386 said YES first, another 382 said "yes" to sharing. We hope for support in sharing this information to county planners and to moving forward together with the Master Plan.

It's very important educational **trail yielding signs are posted** especially with e-bikes getting more popular. All trail users seek peace, safety, confidence, and enjoyment when on public trails. We hope the Equine Land Conservation Resource National Safe Trails Passing Plan of Stop, Speak, and Stand Back <a href="https://elcr.org/trails-safe-passing-plan/">https://elcr.org/trails-safe-passing-plan/</a> is reviewed and implemented as an example of a trails safe passing plan.
