RULES AND GUIDELINES

- 1. This permit is only issued to the occupant of the shelter/event area listed above. The person renting the shelter/event area accepts full responsibility for compliance of these regulations.
- 2. Inflatable permits are only issued if you have rented a shelter or an event area.
- 3. Inflatables must be rented through our approved vendors. Approved Vendors can be verified by contacting the Event Office. If a vendor is not approved and would like to provide the service, they can also contact the Event Office to obtain a one-day permit.
- 4. Inflatables provided by unauthorized vendors or located in prohibited areas will be required to be taken down at the Permittee's expense. It is the Permittee's responsibility to verify that the vendor is approved and to provide them with a copy of the approved permit.
- 5. Parking of vehicles on the grass or other non-designated areas is prohibited. This includes loading and unloading of vehicles and equipment. Supplies and equipment may be carried by a handcart.
- 6. An adult at least 21 years of age must supervise the usage of inflatables at all times.
- 7. Grills and alcohol are prohibited within 25 feet of an inflatable.
- 8. Permit holder agrees to indemnify and hold the City of Detroit, the State of Michigan their departments, boards, agencies, commissions, officers, and employees harmless from all liability because of injury to persons or property arising out of the use of the inflatable for which this permit is granted.
- 9. Limit one (1) inflatable per shelter/event area unless approved by Event Office.
- 10. The \$25.00 permit fee is non-refundable.
