Applicants must contact their local DNR District Office to schedule written examination (see page 2). The applicant must notify the DNR District Office of cancellation at least 24 hours prior to the scheduled examination appointment. Failure to do so shall result in application fee forfeiture. Upon forfeiture of an application fee, applicant must submit a new application and the required fee before the department conducts an examination for the Inland Pilot's license.
