



## INTRODUCTION

A General Management Plan (GMP) develops as a result of a series of planning steps. Each step builds upon the previous, and action decisions focus on the mission of the Parks & Recreation Division (PRD), and the specific Purpose and Significance of the park. Phase I GMP is the first of four phases of planning. This document, Phase 2 Action Plan, is directed by the Phase 1 plan and identifies goals to be attained over the next ten years.

In this phase, the first action is to re-evaluate the General Management Plan to assure that no conditions have changed that would cause a change in the overall guiding document. Having recently adopted the General Management Plan for this recreation area in 2012, it stands as written.

The second phase of management planning for Island Lake Recreation Area (ILRA) establishes long-range action goals for each of the management zones defined in the General Management Plan. For each management zone in the plan, action goals are recommended that address the following categories:

- Natural Resources
- Historic/Cultural Resources
- Recreation Opportunities
- Education/Interpretation Opportunities
- Management Focus
- Development



## BACKGROUND OF ISLAND LAKE RECREATION AREA & OVERVIEW OF PHASE 1

Island Lake Recreation Area, with 4,000 acres is located primarily in Livingston County, Michigan. The Department of Natural Resources (DNR) Parks & Recreation Division completed the Phase I General Management Plan process for Island Lake Recreation Area in 2012. The endeavor represents a new planning philosophy of the PRD. Management Planning, a comprehensive, resource-based process is the PRD's adaptation of National Park Service planning methodology. Through the planning process, the Planning Team (made up of Natural Resource Department staff, government officials, stakeholders and the public) developed the Core Values for Island Lake Recreation Area. Island Lake Recreation Area was determined to be significant for the following reasons:

1. Established in 1944, this park contains about 4,000 acres and provides a wide variety of recreational opportunities.
2. The Huron River, which is a significant natural and cultural resources corridor, runs through the park. The park's portion of the Huron River is managed as a Designated State Natural River.
3. There are 18 miles of marked, designated use trails in the park for land-based recreation and fitness activities and regional events. Land and water trails connect this park to Kensington Metropark to the north, as well as provide links and potential

links to a regional park system, which includes three State Recreation Areas, two Huron Clinton Metroparks, and numerous local parks.

4. The size and location of the park allow it to be used by local schools and municipalities for recreation programs, as well as by visitors from Wayne, Oakland, Washtenaw and Livingston Counties.
5. The park offers educational and interpretive activities through summer day camps, Explorer Guides' programs, and urban outreach programs.
6. The park is historically and culturally significant as the first Dodge Park and as a location for a Spanish-American War encampment. The park contains scattered prehistoric sites, old farmsteads and graveyards. The park is located along land and water transportation routes for Native Americans and early settlers.
7. The park includes a modern shooting range that offers expanded opportunities for educational and recreational purposes.
8. The park has an undeveloped and natural feel, with its hardwoods and unique wetlands. A few areas of oak savannas remain that are being conserved and could be expanded.
9. There is a strong stewardship ethic at Island Lake Recreation Area, carried out by volunteers, the Michigan Civilian Conservation Corps (MCCC) and The Nature Conservancy.

Considering the identity and significance of Island Lake Recreation Area, the Planning Team, with stakeholder and public input, established appropriate Management Zones and the extent of influence on the property. From a palette of nine standard zones, eight were applied to Island Lake Recreation Area as well as a Natural River Corridor. While the full descriptions of these zones are included in the Phase 1 document, a condensed review of the Management Zones follows:

- ☐ Natural River Corridor comprises 745 acres (17.1%) of Island Lake Recreation Area. The Natural River Corridor is a non-standard zone that has been established to focus on the specific management requirements of the Huron River. In general, the 400 foot wide river corridor will be managed in a natural condition, with specific limitation on man-made intrusions and specific goals of maintaining natural vegetative cover and high water quality.
- ☐ Primitive Zone comprises 519 acres (11.9%) of Island Lake Recreation Area. Only foot traffic would be allowed in this zone to ensure that the natural features are not damaged or compromised by recreation. This zone preserves and protects the unique resources found in the western portion of this park.
- ☐ Backcountry Zone comprises 1,156 acres (26.6%) of Island Lake Recreation Area. The zone allows for a slightly higher level of use than the Primitive Zone, but still preserves the natural resources.
- ☐ Cultural Landscape Zone and Overlay combined comprise 200 acres (4.7%) of Island Lake Recreation Area. In the Cultural Landscape Zone, preservation of the historical and cultural resources is the primary management focus. The Cultural Landscape Overlay allows the uses in the underlying zone but addresses the cultural and historical resources found within the park. The former Spanish-

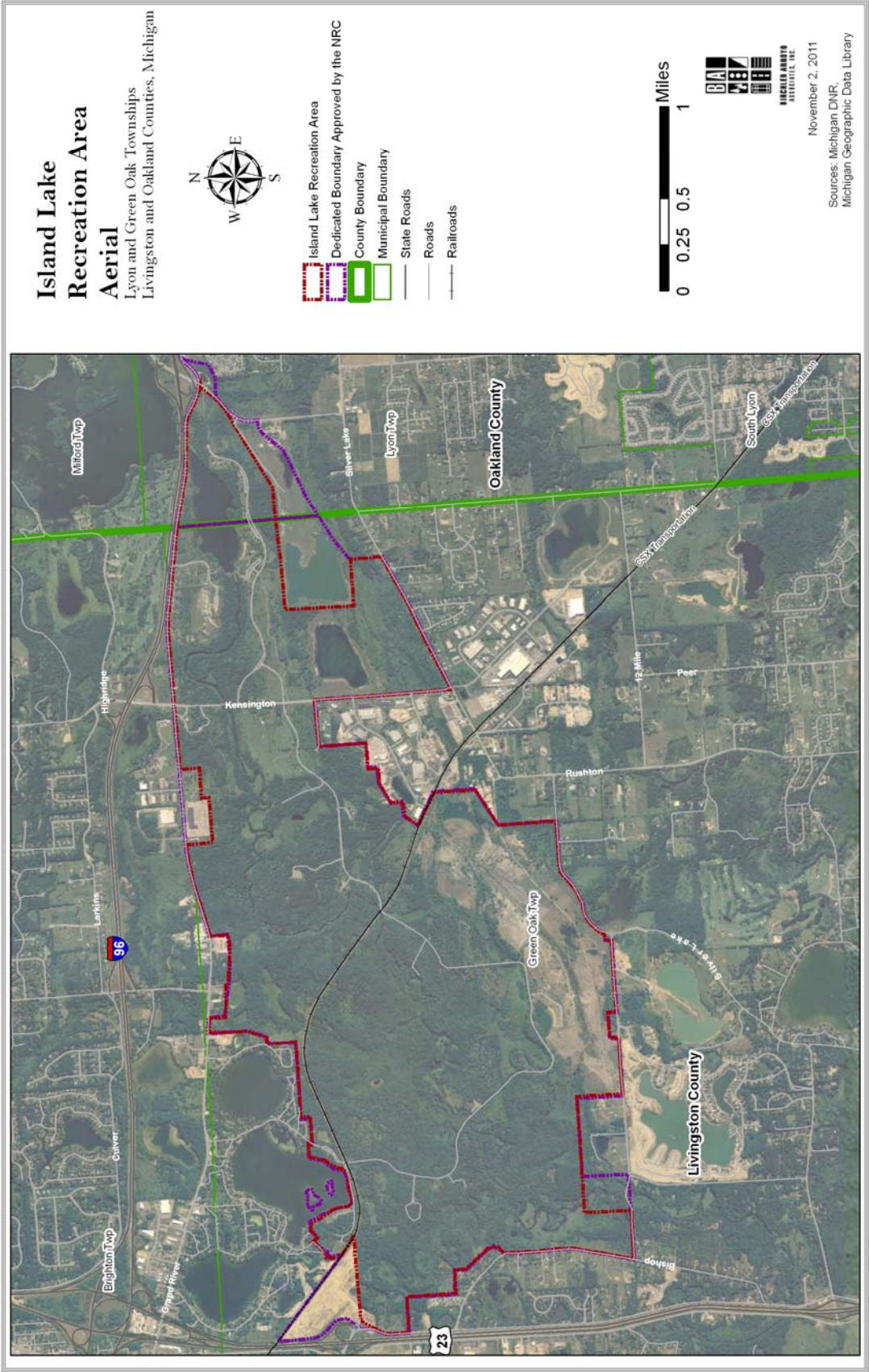
American War Encampment and other important historical features are included in this zone.

- ❑ Scenic Overlay Zone comprises 836 acres (19.2%) of Island Lake Recreation Area. This zone allows the uses in the underlying zone but places a management priority on maintaining the scenic views. The zone encompasses the area managed as a Natural Area in the central-western area of the park.
- ❑ Natural Resource Recreation Zone comprises 811 acres (18.7%) of Island lake Recreation Area and allows for active recreation with medium to high density of use conducted in a natural setting.
- ❑ Developed Recreation Zone comprises 991 acres (22.8%) of Island Lake Recreation Area. Land in this zone is mainly comprised of the park campground, day-use beach, and associated parking areas. The three most developed areas within the park are Kent Lake day use and beach area, Island Lake day use area, and Spring Mill Pond day use and beach area.
- ❑ Visitor Services Zone comprises 25 acres (0.6%) of Island Lake Recreation Area and encompasses the developed areas required for program administration and operations. It includes offices, contact stations, maintenance facilities and all related land required to conduct the business of running a recreation area. The Visitor Services zone in Island Lake Recreation Area includes the existing park office and maintenance facilities.





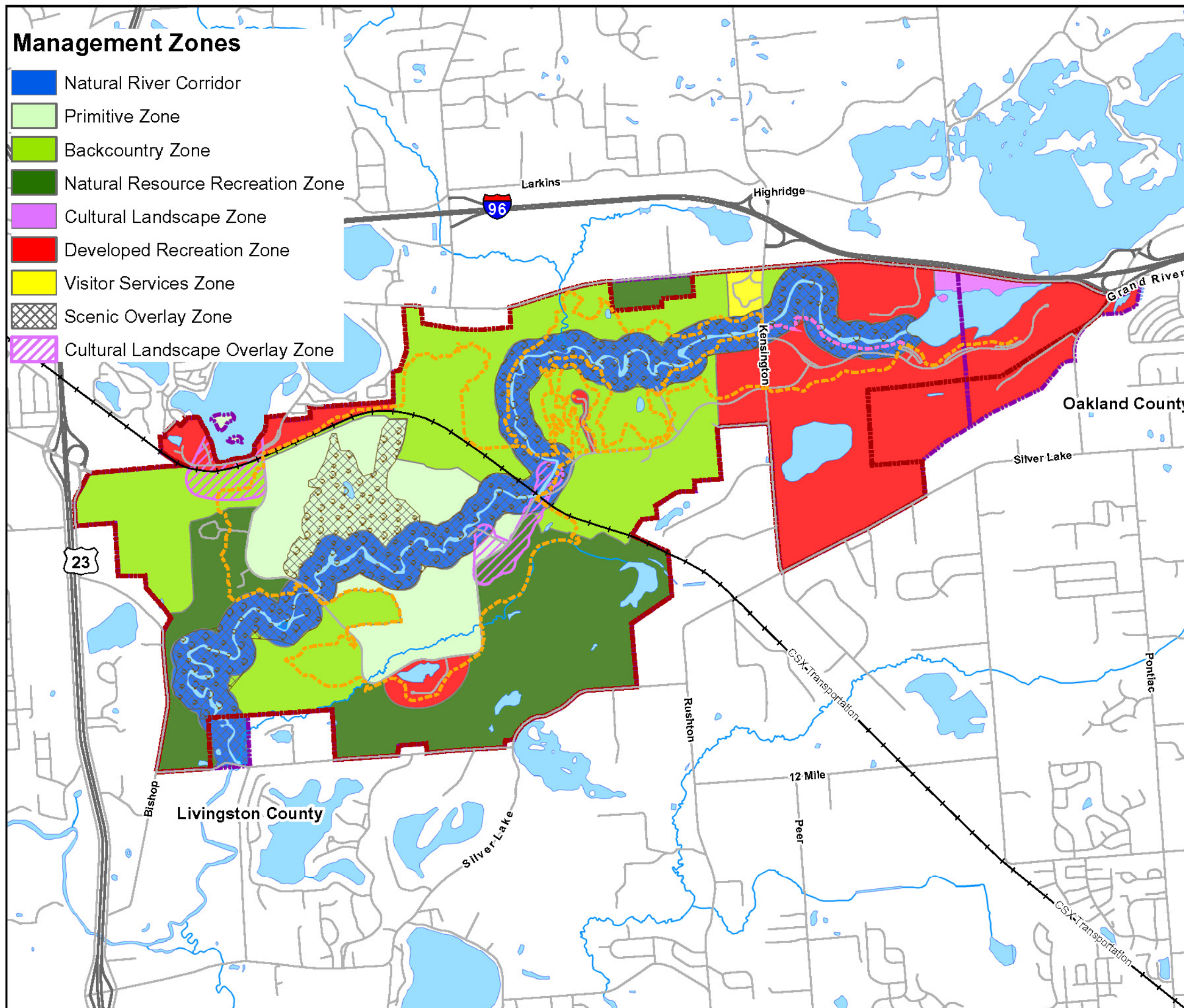

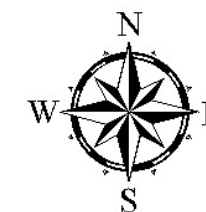

Critical to the Management Planning process is the identification and delineation of “Management Zones”. These are physical sections within the Recreation Area that have defined characteristics and qualities, for which there are related user expectations, management guidance, and defined levels of development. Phase 1 of the General Management Plan for Island Lake developed the Management Zone Map. Phase 2 looks at each management zone and identifies 10-year Action Goals that the Planning Team believes are necessary to guide management and development within the zones in order to achieve the desired user experience.

### **General Action Goals (Applies to the whole park)**

**Many of the 10-Year Action Goals for Island Lake are general in nature and apply within all of the management zones. These often deal with park-wide issues, such as invasive species control, universal access, developing Stewardship, Wildfire and Emergency plans, or marketing the park’s many recreational opportunities to a wider audience of potential users. Many of the overall maintenance and operational issues of operating a state park also result in the need for actions across all zone boundaries, such as law enforcement.**

### Primitive Zone

The Primitive zone emphasizes the natural resources. It is managed to allow only dispersed, low frequency and low impact recreational use in the zone. Maintaining a high quality natural resource condition dictates the extent to which recreational improvements or uses are allowed. For this reason, native species and natural processes take precedence over visitor accommodation. The Action Goals for this zone are included in the General Action Goals for the park and relate primarily to preserving and protecting the natural communities and habitats. No new development is proposed.

### Backcountry Zone

The character of the Backcountry zone is intended to be natural, with minimal evidence of human impact. While the Primitive Zone is highly restrictive for recreational use and human impact, Backcountry allows for increased activity, including bicycle use, and slight modifications of the landscape (trail development) to accommodate that use where it is consistent with protection of the resource. Tolerance for natural resource impacts is low in the Backcountry zone and the 10-year Action Goals for this zone focus primarily on improving existing facilities rather than new development.

### Natural Resource Recreation Zone

Active recreation, at medium to high density of use, conducted in a natural setting is the hallmark of the Natural Resource Recreation zone. There is still an emphasis on resource quality over recreation, but in this zone, higher levels of use are allowed. Vegetation may be managed to facilitate recreational use and maintaining an aesthetically appealing landscape, as well as to address such things as hazard trees, and to manage pests and disease. The 10-year Action Goals are intended to promote moderate to high levels of recreation compatible with natural character of the zone. Action goals for this zone focus primarily on the reclamation of the mining area. Specific outdoor activities are yet to be determined for this area but could allow moderate to high levels of recreation activity compatible with the natural resources of the zone.

# Appendix A –Summary of Public Input

## **Public Participation**

The Department of Natural Resources Parks & Recreation Division (DNR-PRD) emphasizes that comments on the general management plans are accepted at any time during the process. Two structured approaches to gathering public input are included in the general management plan process. Additionally, an on-site park user questionnaire was employed to solicit public input. The participation initiatives are summarized below, and the results are presented in this Appendix.

### **❑ December 17, 2012 Stakeholder and Recreation Partner Workshop**

The purpose of the workshop was to obtain comments on the draft Long-Range Action Goals Plan for Island Lake Recreation Area. With assistance from the Planning Team, approximately 50 people and/or organizations were identified as stakeholders. Invitations to the Stakeholder Workshop were sent by email and via post. Approximately 15 people attended the workshop.

There were three opportunities to provide comments:

- 1) Sticky Note Prioritization Activity – use sticky dots to identify action steps that they would like the DNR to prioritize
- 2) Additional Comments Sheet – provide additional comments/recommendations
- 3) Group Discussion – share ideas with other stakeholders in a group setting

### **❑ March 13, 2013 Public Input Open House**

A public input open house was held to allow the public the opportunity to express their comments about the park. The above noted people were again contacted regarding the public input workshops by mail and email. A notice was published in the local paper. Stakeholders and others were encouraged to share this information with interested members of the general public. Approximately 30 people attended.

There were two opportunities to provide comments:

- 1) Sticky Note Prioritization Activity – see above
- 2) Additional Comments Sheet – see above

#### **☐ July 8, 2013 through August 3, 2013 Park User Questionnaire**

In order to extend the public outreach to a wider cross-section of park users, an on-site questionnaire was conducted at Island Lake Recreation Area. Between July 8 and August 3, 2013, park staff asked visitors five questions about their visit to the park. A total of 408 responses were collected at variable times throughout the day and throughout the week. Although the data gathered captured a wide demographic, it reflects summer use only and accounts for approximately 0.4% of all visitors to the park between the July 8 and August 3 timeframe. The questionnaire results helped to confirm the Action Goals developed for the park and provided additional information for park management staff.

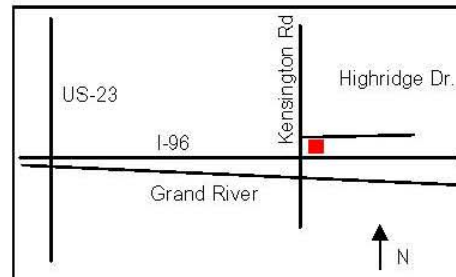

The Department of Natural Resources today announced it will hold an open house on Wednesday, March 13, inviting the public to provide input on the proposed Phase 2 General Management Plan for [Island Lake Recreation Area](#) in Livingston and Oakland counties. The open house will run from 6 to 8 p.m. at Kent Lake Elementary School (cafeteria), located at 30181 Kent Lake Road, in South Lyon.

According to Ron Olson, chief of the DNR's Parks and Recreation Division, these general management plans help staff update previous plans and create a long-term vision for the future. The Phase 1 plan was approved in January 2013. The Phase 2 plan (currently under consultation) considers long-range action goals for the recreation area.

Island Lake Recreation Area provides more than 4,000 acres of public recreational property in Livingston and Oakland counties. The park is home to diverse natural and cultural resources, and has potential for the establishment of the largest oak barrens restoration in Michigan and, possibly, the Midwest. It includes Kent Lake (which connects to Kensington Metropark), Island Lake, Trout Lake, Spring Mill Pond, several lesser ponds, the Huron River (a state-designated Natural River) and a broad spectrum of recreation opportunities.

Along with one of the finest shooting ranges in the state, Island Lake Recreation Area also offers rustic camping, fishing, hunting and trapping, birding, and more than 18 miles of trails for hiking and mountain bike use. The park is linked to Kensington Metropark by both Kent Lake and the Huron Valley Trail.

"Island Lake Recreation Area is one of the most visited parks in southeastern Michigan," said Olson. "As we move forward with the plan for its future, it's important that we hear from the people who enjoy the recreation opportunities available at Island Lake. This open house is a great time to share ideas and learn about the plan."

The DNR's planning consultant, Birchler Arroyo Associates, will host the open house and DNR staff will be available to participate in presenting an overview of the planning process and to address questions from the public about the park and planning efforts already under way.

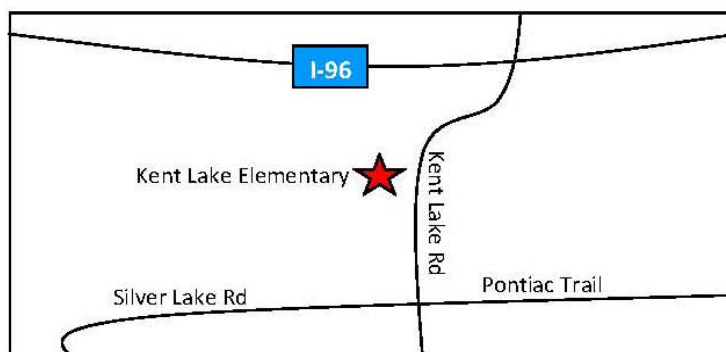

Dear Ms. Jensen/Mr. Birchler,

I appreciated the opportunity to participate in the public open house for Island Lake Recreation Area last week. I found the system for providing input to be somewhat limiting, so I wish to provide some additional comments.

Though I live about 30 minutes away, I use the park once or twice a month, in all seasons and in a variety of ways (mostly road biking and hiking, so far). I feel Island Lake works quite well the way it is. I have experienced little conflict with other types of users, and I even feel the invasive species are not as bad as most other parks I visit. I feel the DNR is doing a good job at Island Lake and would recommend no significant changes.

I feel that the greatest value of ILRA lies in the simple fact that it is a large, contiguous parcel of relatively undeveloped land in an area that is otherwise seeing rapid development. Therefore, protecting and preserving the natural amenities of the park should be the highest priority. In particular:

- Vigorous efforts should be made to acquire any remaining undeveloped adjacent parcels.
- The western section designated Natural Resource Recreation should be re-zoned to create a larger contiguous Backcountry area (excluding small areas around the group campground and cabins if necessary).
- Motorized recreation is incompatible with protecting the park's natural amenities. I believe ATVs, motorcycles, etc. are already prohibited; snowmobiles should be as well.
- Significant additional infrastructure (parking areas, additional entrance(s), etc.) would damage the quality of the resource, not to mention complicating administration, checking for permits, etc. in the case of an additional entrance.

Investing in additional infrastructure to cope with peak demand that only occurs a few days of the year doesn't make economic sense, either. Visitors who can't be accommodated at ILRA should be directed to other area parks.

Again, thank you for the opportunity to be involved in this process.

**Island Lake Phase 2 General Management Plan**  
**Park User Questionnaire**  
**July 15, 2013 through August 3, 2013**

A park user questionnaire was conducted at Island Lake Recreation Area between July 15 and August 3, 2013. Park staff asked visitors five questions about their visit to the park. A total of 408 responses were collected at variable times throughout the day and throughout the week. During the week, visitors were questioned at the park contact station: at busier times on the weekend, visitors were questioned at key locations within the park. Although the data gathered captured a wide demographic, it reflects summer use only and accounts for approximately 0.4% of the estimated visitors to the park between the July 15 and August 3 timeframe.









Of the 408 responses, most people visited the park for the beach areas. The majority of park visitors polled were from the immediate Brighton area with others coming from the Metro-Detroit region. It is also interesting to note that a portion of the users were first time visitors, while others had been coming to the park for many years and considered it a tradition. In general the most favorable aspect of the park was its beaches, trails and general cleanliness.

Visitors were also asked what changes they would like to see at the park. The majority of respondents like the park the way it is and sited no desired changes. A wide range of other suggestions for improvements were recorded, including bike trail on the road, more trails and bathroom improvements.

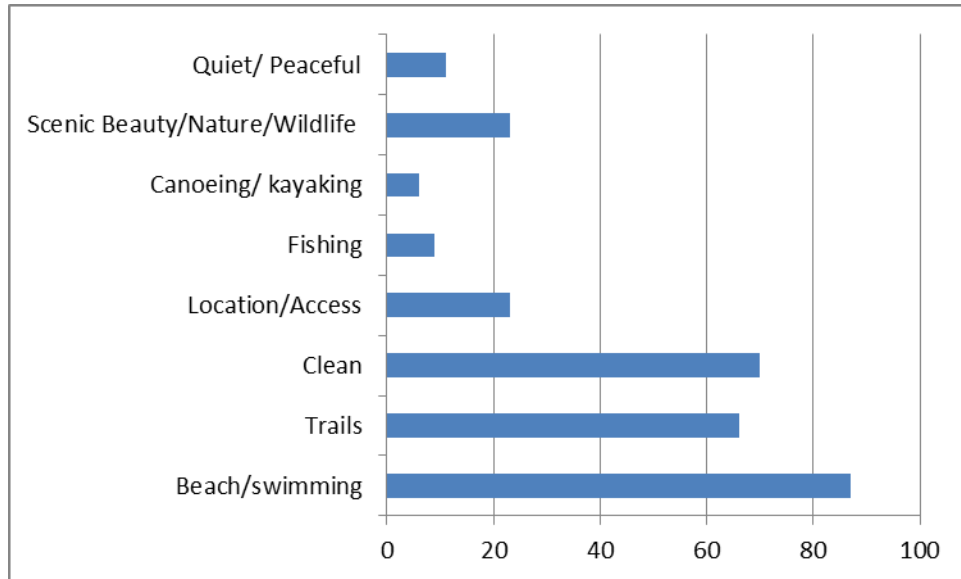

Feedback from Stakeholders

- Adding more year-round modern restrooms
  - Karis – with reduction in use during winter months, it's not economical to put in additional restrooms due to staffing and cost to heat
  - There are 17 port-a-johns available during winter months at key locations
  - All modern restrooms are shut down only during the coldest winter months; buildings are re-opened in March if temps are consistently over 40 degrees
  - Planning Team concurred that park manager is doing everything possible regarding restrooms
- Observation Tower on south side of Trout Lake
  - Karis – good grant project opportunity; work in partnership with Audubon group to seek grant assistance
  - Bird watching has increased at ILRA
  - Lisa – ADA requirements might become an issue with a tower; Debbie – there are alternative options for people who are unable to access the tower
  - Planning Team concurred to add GOAL under Developed Recreation Zone/Recreation Opportunities (#3); time frame = 5 years; regional planner, park manager, and Audubon group
- Camping opportunities that incorporate a yurt or cabin – the Planning Team concurred to add goal to Developed Recreation Zone/Rec. Opportunities (#4)
- Safe trail around railroad trestle
  - Karis – it would be nice to re-route trail so bikes don't have to come out at the road; this would be more feasible than building a bridge; but River makes this not feasible
  - Dave suggested the addition of an on-demand biker/pedestrian activated signal at the cross (this would be far less expensive than a bridge or an under-river tunnel); we need to study various options.
  - Planning Team concurred to add goal to Natural River Corridor/Management Focus (time frame = 1 year; input from regional planner, park manager, fisheries, stewardship) to study options available and recommend action to separate or otherwise protect bike and pedestrian traffic from vehicular traffic
- EMR interpretive panels
  - Change timeframe from 5 years to 1-2 years
- Additional hiking-only trails

- This is an existing goal under Natural Resource Recreation Zone/Rec. Opportunities (#2)
- Biking trails one-direction
  - Karis – this is already in the works; within a year or two proper signage will be in place
  - ADD Goal under General Action Goals/Development (#3) – implement one-way, opposite direction hike/bike trail signs
- West Entrance
  - Karis – entry would be used for heavy weekends and holiday only; this will relieve traffic issues and backups on Kensington Rd, and limit the added cost of manning a second entrance booth
  - This goal is currently under General Action Goals/Development (add Bishop Rd to goal)
- Designated Bike Lanes on State Park Way (main park road)
  - Triathletes use roads because the terrain is more challenging
  - Further study needs regarding the addition of bike lanes
  - Pursue Director's order for bikers to use bike lanes (except on race days)
  - Karis – races held during the week (2 x per month) beginning in May through September
  - ADD goal under General Action Goals (Management Focus)
- Water play zone – change timeframe to 5 years. This is a good opportunity for attracting more families to Spring Mill Pond. Increasing use by families will exert peer pressure to reduce alcohol violations.
