Subject: Generally Accepted Operation Practices for Sport Shooting Ranges

Authority:

Section 1 of 1989 PA 269 (PA 269) and Executive Orders 2009-45, 2009-54, 2011-1, and 2011-2 authorize the Department of Natural Resources (Department) to adopt generally accepted operation practices for sport shooting ranges.

Discussion and Background:

Sport Shooting Ranges, 1989 PA 269, provides civil immunity to persons who operate or use certain sport shooting ranges. The law was amended by Public Act 250 of 1994 to protect owners and operators of shooting ranges from nuisance suits based on noise emanating from the range. Under the terms of the law, an existing sport shooting range in compliance with noise ordinances or laws that existed when the range was established, and operating according to generally accepted operation practices (GAOPs), is afforded this protection.

Once adopted, the GAOPs must be reviewed at least every five years. The most recent review of the GAOPs occurred in 2019 and was based on specifications outlined in the *National Rifle Association (NRA) Range Source Book, A Guide to Planning & Construction, 2012.* During that review, Department staff determined the 2012 edition of the *NRA Range Source Book* had not been modified and, as a result, no changes to the GAOPs were necessary at that time.

In 2023, a revised edition of the *NRA Range Source Book* was published. Staff recently reviewed the 2023 edition and determined that modifications had been made. Based specifically on that review, an outline of "Generally Accepted Operation Practices for Shooting Ranges" is provided below. Note that the *NRA Range Source Book* was designed to provide guidance and direction to the sport/recreational shooting community. The information contained within the manual is advisory and should be considered a set of guidelines rather than absolute requirements for safe and responsible range design and operation. Those portions of the *NRA Range Source Book* which are not included in the GAOPs are considered informational to the named Sections, Chapters and Articles. Because each shooting range is unique, with design and operation of the range being dependent upon its site, surrounding topography, adjoining land ownership, and shooting opportunities offered, not all ranges require identical operating environments or on-site structures.
