This report provides a summary of Payments in Lieu of Taxes (PILT) made by the Michigan Department of Treasury for Taxation Year 2020.

This report includes:

- Total payments made were \$28,909,437.50
- Tax reverted payments totaled \$15,375,443.17
- Purchased land payments totaled \$13,533,994.33
 - The portion of purchased land payments paid by the Department of Treasury was \$8,912,685.16
 - The portion of purchased land payments paid by the School Aid Fund was \$4,621,309.17
