GAME BIRD RELEASE APPLICATION AND PERMIT (TYPE II)

By authority of Part 427, Act 451, PA of 1994, as amended. Failure to comply with the provisions of this Act is a violation state law and may result in fines and/or imprisonment.

A *Game Bird Release Permit* (PR2200) is normally issued by Michigan licensed game bird breeders directly to their customers. However, this *Type II Game Bird Release Permit* (PR2200-1) can be issued by the Michigan Department of Natural Resources, Wildlife Division, Permit Specialist, for sales originating from out of the state, or other circumstances if necessary. This application becomes a valid permit only after being approved and signed by the Permit Specialist (517-284-6210). If approved, the applicant/permittee named below is authorized to possess more than 12 live captive reared pheasants, bobwhite quail, or Hungarian partridge. All birds and/or their eggs must be disposed of within six months from the date of purchase. Birds may be disposed of by personal consumption or may be released within the county indicated. This permit does not authorize the propagation, sale, or other commercialization of game birds. Wild turkeys, or wild turkey hybrids, may not be sold, possessed, or released under the authority of this permit.

The information supplied by me is true and correct to the best of my knowledge I understand that this Permit does not provide any authorization to circumvent any federal, state, local zoning, or any other local laws or ordinances. I understand it is my responsibility to know and comply with federal, state, and local laws.
