Special Investigation Report 2003C0105021

Name of Agency: Woodland Center
Type of Facility: Child Caring Institution – Secure
Type of Population: Delinquent Males

Reason for Investigation:

Youth in facility alleged that he had received oral sex from a female staff. Additional allegations were made on 11/27/02 relative to same staff being inappropriate with youth she supervised.

Dates of Investigation:

Investigation initiated on 10/30/02.
Interviews conducted on 11/4/02, 11/12/02, 12/4/02, 12/5/02, 12/16/02, 01/14/02, and 01/16/02.

Allegations Confirmed:

The initial allegation regarding a female staff giving oral sex to a youth in the facility was not confirmed. The additional allegations made against this same staff were confirmed. Also, at the onsite of the investigation it was disclosed that the initial allegations were not reported for 23 days following knowledge of the information; thus, failure to report immediately was confirmed.

Rule Violations Investigated:

722.623 Sec. 3 Child Protection Law Act No. 238, Public Acts of 1975, as amended, being Sections 722.621-722.638 Michigan Compiled Laws.
R 400.4112 Staff qualifications.

Licensing Recommendation:

The status of the license remains unchanged.

Corrective Action Plan:

Received on 3/4/03 and approved on 3/6/03.
