#### **VIOLATION TYPE**

MCL 436.1217	Right to inspect and search for liquor violation(s)
MCL 436.1609	Licensee receive aid or assistance (rebate, gift, loan)
MCL 436.1701	Misdemeanor to sell or furnish alcohol to a minor
MCL 436.1707	Sell, or serve or allow intoxicated person to consume or loiter
MCL 436.1707(3)	Licensee or employee intoxicated on premises
MCL 436.1707(5)	Allow person under 21 to consume or posses
MCL 436.1707(6)	Employ person under 18 years of age
MCL 436.1801(2)	Sell or furnish alcohol to a minor or intoxicated person
MCL 436.1901	Selling alcohol without a license
MCL 436.1901(2)	Gambling or possession of gambling equipment
MCL 436.1913	Unlawful consumption of alcoholic liquor on unlicensed premises
MCL 436.1916	Dancing or entertainment without permit
MCL 436.2005	Adulterated, misbranded or refilled spirits
MCL 436.2013	Selling or purchasing on credit
MCL 436.2021(2)	Allow alcoholic liquor sold for on-premise consumption to be removed from the premises
MCL 436.2025	Giving away alcoholic liquor on unlicensed premises
MCL 436.2113	Selling before noon on Sunday without permit
R 436.1011(1)	Illegal act on premises
R 436.1011(2)	Licensee convicted of a felony, OUIL, etc.
R 436.1011(4)	Failure to cooperate with law officers (obstruction)
R 436.1011(6)(b)	Knowingly allow soliciting/prostitution
R 436.1011(6)(c)	Allowing fights on/in licensed premises
R 436.1011(6)(d)(e)	Controlled substances/narcotics paraphernalia
R 436.1015	Improper or no display of liquor license/permits
R 436.1019	No contests allowed using alcoholic liquor as the prize
R 436.1023	Alteration, sale or transfer portion of premises without permission
R 436.1031	Sales, service, consumption during license suspension
R 436.1041	Illegal use and benefit of a liquor license
R 436.1403 & R 436.1503	Operation other than legal hours/days
