**MEMORANDUM**

**SUBJECT:** Approval of Request to Change Name of Intermediate School District of St. Clair County

Section 380.604 of the Revised School Code requires that an Intermediate Board of Education obtain the approval of the State Board of Education prior to adopting a distinctive name:

Sec. 604. An intermediate school district is a body corporate governed by an intermediate school board, to be known as "the intermediate school board of the intermediate school district of the county (or counties) of \_\_\_\_\_ and under the name may sue or be sued. The intermediate school board may choose a distinctive name for the intermediate school district if approval is given by the state board.

A letter dated July 20, 2004, has been received from the Superintendent of the Intermediate School District of St. Clair County to change its name to "St. Clair County Regional Educational Service Agency." A copy of the letter of request is attached as Exhibit A.

It is recommended that the State Board of Education approve the request of the Intermediate School District of St. Clair County to change its name to St. Clair County Regional Educational Service Agency, as described in the Superintendent's memorandum dated July 26, 2004.
