General Definitions

Intermediate school districts, local education agencies, and public school academies are all educational entities established by Michigan public law. Their primary mission is the teaching and learning of academic and vocational-technical skills and knowledge.

Intermediate School Districts (ISDs) provide various administrative services and cooperative, coordinated educational services among many school districts in the name of economy and efficiency.

Local Education Agency (LEA) is a public school operating in accordance with statutes, regulations, and policies of the Michigan Department of Education. An LEA has a set geographical boundary and may include any grade configuration along with educational settings (e.g., alternative education, special education, career and technical education).

Public School Academy (PSA), also referred to as a **Charter School**, is a state-supported public school without geographical boundaries. A public school academy may include any grade up to grade 12, including kindergarten and early childhood education, or any configuration of those grades as specified in its contract.

(6) "Public school" means a public elementary or secondary educational entity or agency that is established under this act, has as its primary mission the teaching and learning of academic and vocational-technical skills and knowledge, and is operated by a school district, local act school district, special act school district, intermediate school district, public school academy corporation, strict discipline academy corporation, urban high school academy corporation, or by the department or state board. Public school also includes a laboratory school or other elementary or secondary school that is controlled and operated by a state public university described in section 4, 5, or 6 of article VIII of the state constitution of 1963.

MCL 380.6(1)

(1) "School district" or "local school district" means a general powers school district organized under this act, regardless of previous classification, or a school district of the first class.

PSA: MCL 380.5(7)

(7) "Public school academy" means a public school academy established under part 6a and, except as used in part 6a, also includes an urban high school academy established under part 6c and a strict discipline academy established under sections 1311b to 1311l.
