I. OPENING REMARKS

The August 23, 2017 Michigan Unmanned Aircraft Systems (UAS) was called to order by Chairman Mike Trout at 10:00 a.m.

Chairman Trout welcomed all those present. He asked everyone to rise, and the Pledge of Allegiance was cited.

Roll call was taken by Brigitte Pricco.

II. INTRODUCTIONS

Chairman Trout began by introducing Michigan Department of Transportation (MDOT) staff, task force members were invited to introduce themselves and stated their expectations of the task force.

III. SURVEY RESULTS

Bryan Budds stated that the expectations that were mentioned from the survey results included Privacy, Safety, Economic Development, Uniformity, Harmony with Federal Aviation Administration (FAA) Regulations, and Critical Infrastructure Protection. The most significant issue determined by the survey results was Privacy.

IV. OVERVIEW OF TASK FORCE SCOPE AND CHARGE

Chairman Trout described the scope and charge of the task force. The final report with recommendations are due to the Governor within three months of the first task force meeting.

As part of the report, the task force shall consider commercial and private uses of UAS, landowner and privacy rights, general rules and regulations for safe UAS operations.

V. OVERVIEW OF FEDERAL AND STATE REGULATORY ENVIRONMENT

Bryan Budds presented the current FAA UAS Regulations, which included a short description of Part 107 requirements and limitations. Slides and discussion were also presented regarding the Michigan Unmanned Aircraft Systems Act 436 of 2016. Discussion regarding current Congressional activity to permit state/local regulation of airspace from 200 feet below also occurred.
