To any peace officer or court officer authorized to make arrest: The complaining witness has filed a sworn complaint in this court stating:

**COUNT 1: LYING TO A PEACE OFFICER - VIOLENT CRIME INVESTIGATION**  
after being informed by Special Agent David Dwyre that the officer was conducting a criminal investigation, did knowingly and willfully make a statement or statements to the officer that he or she knew was false or misleading regarding the following material fact or facts relating to the investigation: that she lied when she denied that she was told by witnesses that they were assaulted by Larry Nassar, and the officer was conducting a criminal investigation for Criminal Sexual Conduct First Degree; contrary to MCL 750.479c(2)(d). [750.479C2D]  
FELONY: 4 years and/or \$5,000.00

**COUNT 2: LYING TO A PEACE OFFICER - 4 YEAR OR MORE CRIME INVESTIGATION**  
after being informed by Special Agent David Dwyre, that the officer was conducting a criminal investigation, did knowingly and willfully make a statement or statements to the officer that he or she knew was false or misleading regarding the following material fact or facts relating to the investigation: that she lied when she denied that she was told by witnesses that they were sexually assaulted by Larry Nassar, and the officer was conducting a criminal investigation for Misconduct in Office; contrary to MCL 750.479c(2)(c). [750.479C2C]  
HIGH COURT MISDEMEANOR: 2 years and/or \$5,000.00

Court shall order law enforcement to collect a DNA identification profiling sample before sentencing or disposition, if not taken at arrest.

Upon examination of the complaining witness, I find that the offense(s) charged has/have been committed and that there is probable cause to believe that defendant committed the offense(s). THEREFORE, IN THE NAME OF THE PEOPLE OF THE STATE OF MICHIGAN, I order you to arrest and bring defendant before the 54A District Court immediately.

The defendant may be released before arraignment if \$ 5000 CIS is posted as interim bail
