


Michigan Medicaid Autism Program



Case Manager Guidance Document

Purpose/Directions: Develop Autism Spectrum Disorder (ASD) training guidelines to support professional learning for case managers and supports coordinators working in the Michigan public mental health system.

Introduction: Michigan Medicaid funds, which are paid on a capitated basis per Medicaid-eligible individual, are contracted through Prepaid Inpatient Health Plans (PIHPs), three of which are single-county PIHPs and seven of which are regional entities. Behavioral Health and Developmental Disabilities Administration (BHDDA) services and supports in Michigan are delivered through county-based community mental health services programs (CMHSPs). Michigan Department of Health and Human Services (MDHHS), along with these 46 regional CMHSPs and 10 PIHPs, contracts public funds for mental health, substance abuse prevention and treatment, and developmental disability services. Substance abuse services are purchased through the 10 PIHPs and delivered through local Recovery Oriented Systems of Care.
