- PROPOSALS:** Sealed proposals are invited for a Roofing Project for Bedford Public Schools at Bedford High School, 8225 Jackman Rd, Temperance, Michigan. All applicable laws, ordinances, rules and regulations of all authorities having jurisdiction over the construction and renovation of a public school building shall apply to the contract throughout and to the project to be completed. These include, the Construction of School Buildings Act, Act 306 of 1937 and the Michigan Revised School Code, including but not limited to Sections 1263 and 1267.

Bids will be opened and read aloud publicly by a designee of Bedford Public Schools and its administrator at the above address immediately following the deadline for the receipt of bids. - PROPOSAL GUARANTEE:** The proposal must be accompanied by a certified check or bid bond by an approved surety company in the amount of five percent (5%) of the proposal submitted. Proposals shall remain firm for a period of sixty (60) days after official opening of bids.
- CONTRACT SECURITY:** The successful Contractor will be required to furnish performance, labor and material bonds, each in the full amount of the proposal.
- FAMILIAL RELATIONSHIPS:** The bid shall be accompanied by a sworn and notarized statement disclosing any familial relationship that exist between the owner or any employees of the bidder or any member of the Board of Bedford Public Schools, the Intermediate School Board, Intermediate Superintendent of the Intermediate school district; or the chief executive officer or administrator of Bedford Public Schools.
