The Board of Education of Fenton Area Public Schools will receive firm prime contractor bids for all labor, materials, equipment and all other services to complete the Fenton Intermediate School gymnasium removal and site improvements including but not limited to paving, site lighting and landscaping, located in the Fenton Area Public School District.

The bidding documents consist of plans and specifications as prepared by Beta Design, 70 Ionia Avenue, SW, Suite 400, Grand Rapids, Michigan 49503. Documents may be obtained at George W. A pre-bid meeting is scheduled for **Tuesday, April 27, 2010 at 4:00 p.m.** at Fenton Intermediate School 404 W. Ellen, Fenton, MI 48430.

The envelope bearing your proposal must identify your company and the proposal being bid and addressed to the attention of Ms. Peggy Yates, Superintendent, Fenton Area Public Schools, 3100 Owen Road, Fenton, Michigan 48430. Bids must be delivered no later than **12:00 noon, May 4th, 2010** to Fenton Area Public Schools at the address noted above or the George W. Auch Company. Each proposal must be submitted on the forms furnished in the project manual and must be completed in full. Each proposal shall be sealed in an opaque envelope and marked with the name of the bidder. A bid bond executed by a **U.S. Treasury listed surety company** acceptable to the Fenton Area Public Schools, or a cashier's check in the amount of at least 5% of the sum of the proposal payable to Fenton Area Public Schools shall be submitted with each proposal in excess of \$20,998. All proposals shall be firm for a period of sixty (60) days.

Bids will be publicly opened and read at a meeting at the Fenton Area Public Schools Administration Building, 3100 Owen Road, Fenton, Michigan 48430 starting at **2:00 p.m., May 4th, 2010.**

Successful bidders whose proposals are \$50,000 or more will be required to furnish a Satisfactory Performance and Payment Bond in the amount of 100% of their bid. The cost of the Bond shall be included in each proposal.

The Board of Education reserves the right to reject any and/or all bids in whole or in part and to waive any informalities therein. The Board of Education reserves the right to accept that bid which in its opinion, is in the best interest of the Owner.
