# **Talking Points for School Leaders**

#### **New Developments with MILogin for Third Party Accounts**



Thank you for your work and communication to your region concerning the need for a MILogin for Third Party account. When we started the focused outreach a few weeks ago, the match rate was only 21%. We are happy to report that your efforts are working—the match rate is currently 67% for MI School Data and MILogin for Third Party accounts. With public access to the redesigned portal delayed by a

month, we requested that the deadline for MILogin for Third Party accounts be extended. CEPI has granted an

extension for the MILogin for Third Party accounts to July 31, 2020.

We have once again provided you with the resources and steps necessary to migrate to the new system. Please continue to assist users within your service area.

- To retain current secure login status users need to create MILogin Third Party account. MILogin Third Party Website: <a href="https://milogintp.michigan.gov/eai/tplogin/authenticate?URL=/">https://milogintp.michigan.gov/eai/tplogin/authenticate?URL=/</a>
- 2. Use the same email address/credentials as current MI School Data account. This must be completed by July 31.
- 3. Security rights should transfer if the account is created before the migration date on August 1, 2020.

CEPI has created a <u>MI School Data Secure Account Migration to MILogin</u> to assist secure users with processes, communication steps, and FAQs. After July 31, users will need to fill out a security form and request a new account after the new MI School Data site is launched.




#### MI School Data Spotlight on Redesign Website and Personas

#### **MI School Data Report Releases**

#### **Recently Released**

- <u>At-Risk Student Report</u> identifies the number and percentage of "at-risk" third and eleventh grade students who were proficient on the M-STEP and SAT. Eighth grade Math PSAT data are now included in this report (2018-19 data).
- <u>Data Files</u> new cross-tabulated files have been added to the Assessment and Accountability section. The PSAT, SAT, MI-Access and Student Growth cross-tabulated files include data for the subgroups of gender, race/ethnicity, English Learners, and students with disabilities in compliance with ESSA requirements. Cross-tabulated M-STEP and test participation data are planned for release later this year (beginning with 2018-19 data).
- **NEW** School Level Expenditure Report expenditure breakdown by local, state, federal funds for LEA/PSAs in compliance with ESSA. Comparisons available at the school level/district, county, city, and ISD with multiple visual comparison tools (beginning with 2018-19 data).
- <u>Student Pathways Report</u> This report requires a secure login and shows student-level information on college enrollment, coursework, cumulative credit, program and award information, and GPAs from in-state and outof-state colleges and universities (2018-19 data).
