Pursuant to P.A. 245 of 2008
Section 403(3)
Parolee Success Rates by MPRI Site
September 30, 2009

Section 403(3) of 2008 P.A. 245 requires that the Department of Corrections provide a report on a comparison of the overall recidivism rates and length of time prior to prison return of offenders who participated in the MPRI with those of offenders who did not. The report should disaggregate the information by each site in order to compare the practices and success rates of each site.

It is important to note that the latest preliminary tracking analysis for the quarterly MPRI Status Report shows that, **on a statewide basis, parolees who have participated in the MPRI have seen a 32% relative rate reduction in total returns to prison when compared to baseline failure rates and controlling for history of prior parole failure and time at risk of recidivism. This translates into an absolute reduction of 2,083 fewer returns to prison so far through September 2009 when compared to baseline expectations.**

The numerical reduction in the returns to prison will continue to grow if these results can be sustained over a full three-year follow-up period for all of the MPRI parolees who have transitioned to the community so far.

Because the MPRI involves an intensive reinvestment of corrections resources in the community and follows an evidence-based practices model, the programming and services made available through the MPRI are reserved for parolees who are at moderate to high risk for recidivism due to criminogenic factors that the services are designed to address.

Thus, when comparing MPRI Parolees to All Other Parolees either statewide or for a given site, please be advised that each group would necessarily require a completely separate baseline for comparative measurement because MPRI parolees are quantifiably higher risk offenders than other parolees. Simply comparing the two statewide tables, or the two tables for an individual site, to one another would be an apples-to-oranges comparison that would not provide valid and reliable measurement of the actual impact that MPRI has had on the recidivism outcomes of MPRI participants.

A valid comparison would require matching the characteristics of the offenders to control for inherent differences between the MPRI Paroles and the All Other Paroles subgroups on measures such as risk and criminogenic needs (which the raw statewide and site-by-site numerical tables do not do).

As proof of performance that the MPRI is targeting its interventions on parolees who have the highest likelihood of failure, the majority of MPRI parolees have a history of prior parole failure - a subgroup that had a 24% greater rate of again failing on parole in the 1998 baseline data (62% of baseline cases with a history of prior parole failure returned to prison within 3 years, versus 38% of baseline cases with no history of prior parole failure).

The repetitive cycle of misbehavior among parolees with a prior history of parole failure is precisely what the MPRI is designed to stop - via its features of dynamic risk assessment, transition accountability planning, program intervention and community in-reach in advance of the next release.

Reducing the failure rates of those typically returned to prison 62% of the time to less than 50% of the time is a tremendous early achievement of the MPRI (especially since the full MPRI model is not yet completely in place and up to scale), even if that rate remains somewhat higher than the rate for the lower risk offenders that are present in the All Other Paroles subgroup.

All prisoners who paroled to Michigan Counties between January 1, 2005 and July 31, 2009 are included in the attached site-by-site analysis. During this period, there were a total of 49,603 paroles, not including 2,588 who either paroled in custody or paroled out of state. All transits between the parole date and September 30, 2009 were used to measure return to prison and time to return for up to three years following release to parole. As a result, each offender included in the tables has at least two full months of follow up. Returns to prison for technical violations or for new sentences (even after the parole term ended) are counted.

The following two series of tables are grouped by official standard MPRI participation versus not:

I. MPRI Paroles - i.e., Official standard MPRI cases paroled from MPRI site facilities.

II. All Other Paroles.

Within each of these groups, a separate table is provided for Statewide and then for each MPRI site. The sites as reported reflect the latest county configurations for the MPRI sites (See Map 1 and Tables 1 & 2).

Within each table the data are reported by the number of months of follow up. A prisoner who paroled on July 31, 2009 would only have two months of follow-up (i.e., August-September 2009); while an offender paroled on or before September 30, 2006 would have had the full 36 months of follow up. Each offender included in a month is also included in prior months. For example, an offender in the three months of follow-up group had also been followed up for one month and for two months.

For example, in the first table (MPRI Parolees - State Wide) there are 16,065 MPRI Paroles. Since each parolee has at least one month of follow up, this number is found in the row with the "1" in the "Follow-Up" column and under the column of "Total Parolees at Risk". Forty-eight of these MPRI parolees were returned to prison as technical violators within one month of being paroled (0.3%). Continuing to the next row (2 months of follow-up) there were 16,060 parolees followed up for at least two months. These parolees are also included the row above because they were followed up for one month too. One hundred and twenty-eight of the 16,060 were returned to prison within the first two months after release for technical violations (0.8%) and ten were returned with new sentences (0.1%).

Since the parolees are not followed up for the same amount of time, the columns cannot be added, nor are the columns cumulative. And note that fewer than half of the parolees represented

in the table have been followed up for as long as 18 months, and that only about 6% have been followed-up for a full 36 months.

Consequently, the results in the tables of this analysis must still be regarded as preliminary due to the limited number and percentage of cases that have been in the community long enough to have completed a full three years of follow-up. In addition, breaking the cases down site-by-site further reduces the numbers of offenders in each table who have completed a fixed 36-month follow-up period, rendering the data unreliable as indicators of long term trends at this level of detail this early. Instead, it is much more reliable to make judgments based on the statewide MPRI outcomes summary against the baseline data (which is found in the first page immediately after this narrative).

It must be remembered that the MPRI is being implemented in stages, and critical elements are not yet fully in place, such as broad implementation of prison programming that is completely evidence-based and tailored to the criminogenic needs of the individual offenders.

It is also important to recognize that the only MPRI parolees in the tables who have completed the 36-month follow-up period are among the very first cases that were identified for targeting by the MPRI initiative at its inception - well before many of the most key elements of the MPRI model were in place.

Finally, when reviewing the site-by-site tables (especially across sites), it is also important to take note of the other factor (besides history of prior parole failure) that is already proven to be very significant in the differentiation between release outcomes – namely, the County of Release.

The baseline failure rates at three years following release for all 1998 paroles to the various MPRI sites ranged from a low of 28% returned to prison to a high of 61% returned to prison.

This variation is likely driven by local prosecutorial charging and plea bargaining practices as well as local issues such as economic/employment and housing prospects within depressed areas. Local community failure rates leading to return to prison can also be affected by community corrections practices, including both:

- Which types of local felons are typically sentenced to prison rather than diverted to community-based sanctions, as well as
- What community-based initiatives may or may not be present in a given locality - such as drug courts, mental health diversion programs, and comprehensive sex offender management practices.

MPRI-Related Participant Outcomes through September 2009

- **As MPRI moves up to scale, it has already involved significant numbers of cases:**
 - 20,312 engaged from MPRI inception through September 2009 in IRU or MPRI release cohorts.
 - 19,105 (94%) of these had been released to parole by the end of July 2009.
- **MPRI is targeting offenders who are otherwise likely to fail on parole:**
 - Offenders who have a prior history of parole failure are **24%** more likely to fail again.
 - **51%** of MPRI cases released through September 2009 had a history of prior parole failure.
 - Only **35%** of all paroles in the 1998 baseline year had a history of prior parole failure.
- **MPRI outcomes through September 2009 show a 32% relative rate reduction in total returns to prison:**
 - **2,083** fewer returns to prison than baseline expectations so far (4,408 actual vs. 6,491 expected).

MAP 1: MPRI Site County Configuration

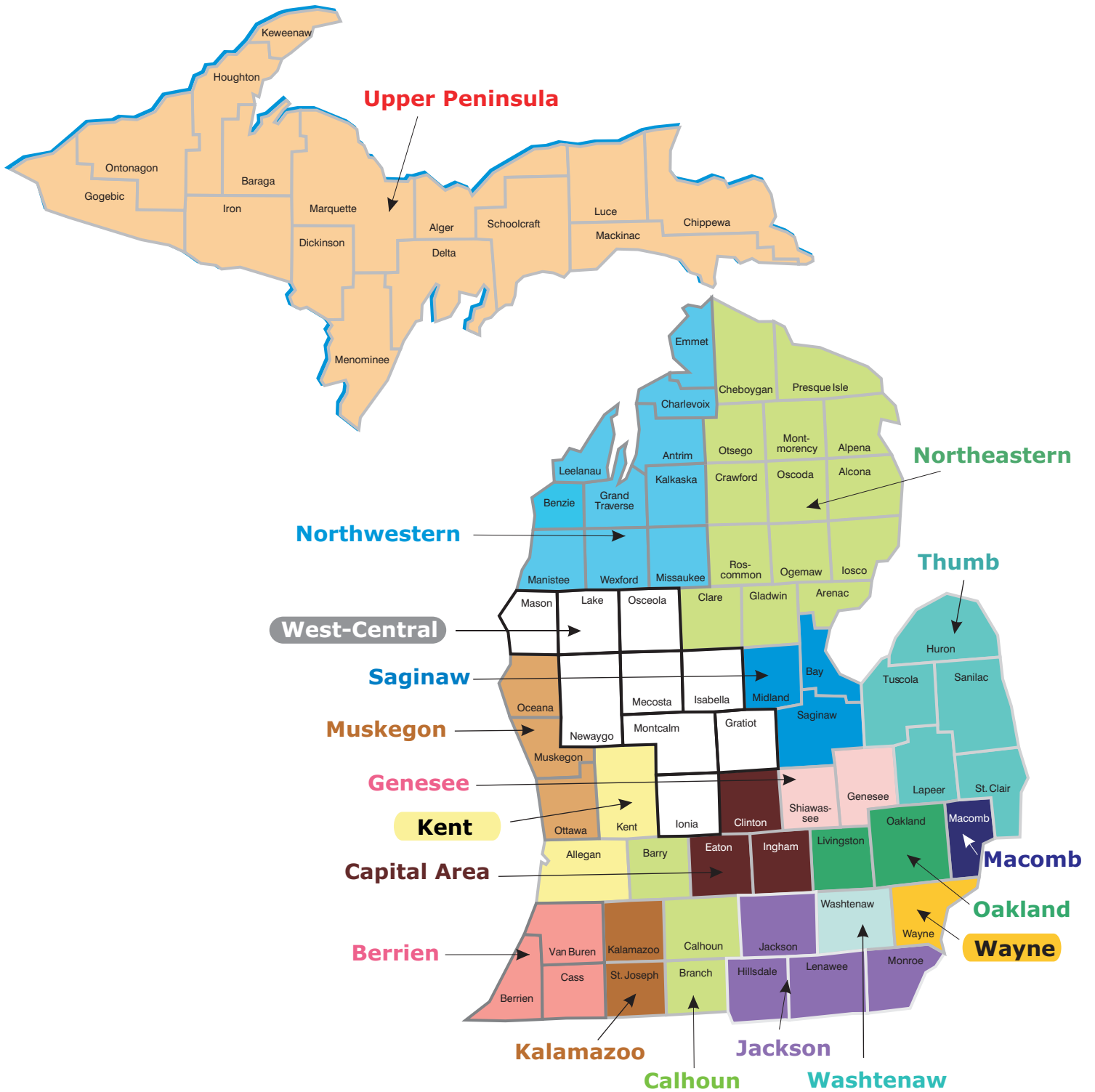
