The Michigan Children's Trust Fund (CTF), was established in 1982 to fund the critical activities of organizations on the front lines of child abuse and neglect prevention across the state of Michigan. CTF serves as the state's chapter of Prevent Child Abuse America, as well as facilitating, funding, and supporting over 100 child abuse prevention programs across all 83 counties. These programs currently support 72 local primary prevention programs and approximately 30 secondary prevention grants. Our donors- people like you - are our most important source of funding for the organizations who are protecting Michigan's most vulnerable residents, our children.

CTF is uniquely positioned to lead and support prevention activities in Michigan through our public-private structure. 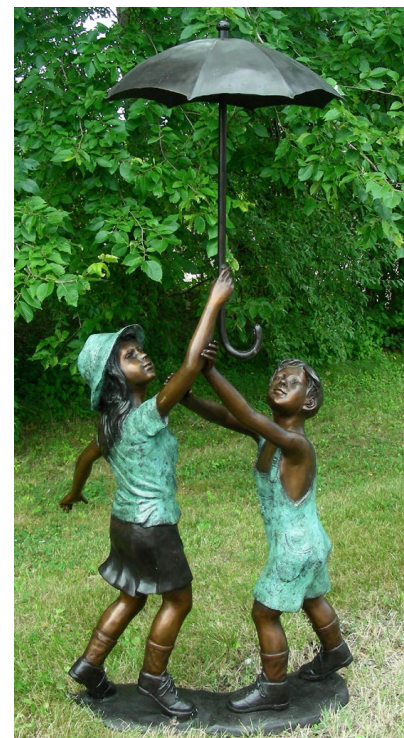


