The NWCAC is a child friendly facility where a team of professionals from our center, law enforcement, child protective services and the Prosecutor's office meet to interview children, make decisions about investigation, treatment and prosecution of child abuse cases. The NWCAC also works to prevent the further victimization of children.

Services Provided:

- Forensic interviews to alleged child victims of abuse
- Crisis counseling for the non-offending caregivers and the child victims of abuse
- Emergency pediatric exams performed by sexual assault nurse examiners
- Advocacy for child victims and their families
- Referrals to community agencies and resources
- Crime victims rights education and compensation information

All the services we provide are cost free to the family of the child victims. These services are invaluable to the victims and their families. We are funded solely by donations, grants and fundraising efforts. We rely on the generosity of our donors to provide these services. The NWCAC has helped hundreds of abused and neglected children in Bay County.
