Project: Big Brothers Big Sisters of Metropolitan Detroit (BBBSMD) will provide secondary child abuse and neglect services for families by providing community-based mentors to youth who have a parent that is currently incarcerated. Mentors will meet no less than 4 hours per month with their assigned youth to engage in support and activities designed to positively develop social and emotional competence within the youth. Mentors will also provide brief respite periods for the parent of each youth by involving the youth in activities outside of the home. Additionally, BBBSMD will offer training in the Strengthening Families model to parents and mentors through the local Child Abuse and Neglect Council, at their recommendation to provide this service in the development of this funding request. This training will ensure that both the parent and the mentor are fully informed on the Strengthening Families framework and able to apply it in their daily interactions with the involved youth. Expected outcomes for this project include: parents will understand how to foster their youth's optimal developmental achievement; youth will use prosocial behaviors to communicate and to get their needs met; and parents and mentors will practice appropriate and effective strategies for mediating youth's challenging behaviors within the context of the Strengthening Families model.

Project: The purpose of the Caring & Sharing Nurturing Families project is to prevent the maltreatment of children through the application of the "Nurturing Families," evidence based program by Stephen J. Target Population: We will specifically provide outreach and engagement in Parents as Teachers or homeless families in this expansion.

We will also target families with older youth (ages 3-5) who experiencing significant barriers to enrollment in preschool.

Project: The Seeds for Success Parents as Teachers Consortium began providing services in 2012 to reach families who were literally "falling through the cracks" in our community. By providing home-based services and using a proven model, Seeds for Success has been able to engage over 300 families each year (345 so far in 2017) and to produce positive outcomes working alongside these families. The families we serve often have a variety of high needs characteristics. Currently, 14% are teen parents, 82% come from low income households, 35% have low educational attainment (not high school diploma or GED), 21% are dealing with substance abuse issues in their immediate family, 12% are homeless (not including those precariously housed), and 21% are currently or have dealt with domestic violence in the households. As the Kalamazoo County data presented above indicates, however, there are still significant gaps in service in Kalamazoo and the knowledge of these gaps -- specifically for homeless families and families experiencing significant barriers to accessing early education services -- led directly to the development of this proposal.

The Parents as Teachers model, currently successfully used by the Consortium, will be utilized to serve these high-risk families. The model has been proven to effectively impact families with





multiple high needs characteristics, such as these. Services will be provided to each family in their homes -- homeless families will be served at shelters, in transitional housing, or in other safe community locations -- overcoming barriers to access and transportation. Parent Educators will use a variety of proven techniques, including routine assessment/screening, personal home visits, group connections, and access to a strong resource network as they engage and support families.

Target Population: The Lenawee's CHILD program provides universal services to families with children between the ages of birth and five years of age. 

Project: The purpose of this project is to augment Motherly Intercession's current program service delivery by; integrating a Circle of Parents component into the Strengthening Incarcerated Families (SIF) Program Model and further expanding its service delivery by increasing its focus on the male inmate population in the Genesee County jail and previously incarcerated fathers in the community.

Motherly Intercession will apply its Family Stress Model (Please see Logic Model SIF & PWI Family Stress in attachments) to reduce the risk of child abuse and neglect among the parents and alternate caregivers for children of currently or previously incarcerated mothers or fathers of Flint (Genesee County) Michigan. Parents and alternate caregivers; whose lives has been negatively impacted by multiple traumatic experiences (i.e. victimization during their own childhood, the poisonous Flint water crisis, incarceration, community violence, poor economic conditions, generational poverty and other challenges). All of which further increase the risk for traumatic stress disorders among the parents and alternate caregivers who are responsible for the care of young children. The enhancement of the programs and wraparound services that are provided by Motherly Intercession coupled with expansion efforts to include a larger segment of the

Both programs with their respective broad scope and a more strategic focus will be launched in our selected Counties of Clare County and Gladwin.

The Strengthening Families Approach and Safer, Smarter Kids support secondary direct prevention programs that are designed to prevent child abuse and neglect and build protective factors. This project utilizes the protective factors that are integral to children as they develop strong self- identities and healthy relationships. But these relationships are not learned nor fostered in a vacuum. Children must have responsible, supportive adult care takers to survive and thrive. A review of the literature predicts children who are nurtured by caring, supportive families are better executive decision makers, practice fewer risk taking behaviors, are better adjusted, accept appropriate boundaries, demonstrate increased frequency of competency both intellectually and in social situations, and practice resiliency when confronted with challenges and opportunities.

Parents as Teachers equips families with children up to the age of 5 with the information and tools necessary to provide a healthy and safe home using five protective factors to strengthen families: prenatal resilience, social connections, knowledge of parenting and child development, concrete supports in times of need, and children's social and emotional development. Our PAT Affiliate program delivers home visits directly into the homes of our most at-risk families. We provide at least one group connection per month, offer developmental screenings and connect families to available resources and supports. The number of visits per family is based on the family risk-factors with a minimum of one home visit per month. Families enrolled in PAT have fewer documented cases of abuse and neglect compared to state average based on the "Second Wave" study which examined 400 families enrolled in 37 diverse school districts. Our intention with this project is to significantly decrease the number of children, newborn to age 5, suffering from abuse and neglect.

Nurturing Skills for Families also works to strengthen families. The goal of this intervention is to provide parents with the necessary knowledge, skills, resources and services to build upon their parenting strengths and prevent the abuse and neglect of their children. The Nurturing Skills Program delivered through Born to Thrive will be integrated with Strengthening Families *philosophy* which is woven into all program service delivery at WMFC. Monthly specials will be held designed to focus on the strengthening families protective factors. Activities that address a child's social and emotional development will be addressed each month. Examples of monthly family specials may include: an agency fair to personally introduce families to the various services available in the community demonstrates Concrete Supports. A parent tea, spa or other such event that encourages parents to get to know other parents in the program-enhances Social Connections and shows value and respect for parents. A Parent Super Hero night provides fun, interactive activities and would focus on parental resilience (what that is and how to improve it) and parenting and child development (how understanding children makes Super Heroes out of parents!) Born to Thrive was designed to meet the specific and culturally unique needs of the families that live in this community. To facilitate relationship development any individual hired into this program will have local knowledge and will possess a clear and historical understanding of the population, the local colloquialisms and the unique culture of the region.
