The Michigan Children's Trust Fund Reinvests All Tax Check-off Contributions to Communities of Origin



Michigan taxpayers can take advantage of the opportunity to increase the child abuse prevention funding in their communities by making a tax deductible contribution when filing the Michigan tax return. When you do your Michigan taxes, look for Michigan Tax Form 4642, which is the Voluntary Contribution Schedule. CTF is listed, along with other charities, as "Children's Trust Fund – Preventing Child Abuse in Michigan."

All tax check-off contributions made to the Michigan Children's Trust Fund will be returned to the communities of origin. Based on local priorities, local programs use funding for initiatives such as shaken baby prevention and safe sleep education, parent support, child sexual assault prevention and education, welcome baby supports for new families, and community wide education to strengthen families and prevent child abuse and neglect.

Please remember CTF when filing your state income taxes. Look for Michigan Tax Form 4642, Voluntary Contribution Schedule, and check to protect.

Child Abuse Prevention (CAP) Month is Only Two Months Away

It is definitely March, that time of year when; the days are noticeably longer, the sky seems bluer, we're looking forward to warmer weather (even though we are most likely freezing), and we realize that Child Abuse Prevention Month is only one month away. Since 1983 April has been designated by presidential decree as Child Abuse Prevention (CAP) Month. During each April, organizations actively engaged in child maltreatment prevention work within Michigan and across our nation pause to acknowledge the issues of child abuse and neglect, and educate the public about the great prevention work being accomplished to strengthen families so that all of our children may thrive.

Research is increasingly demonstrating the important role prevention has in helping to build a healthier and more vibrant society. Because of the Adverse Childhood Experiences survey and other research data being collected nationwide (including in Michigan), we are learning that childhood trauma (adverse experiences) can negatively affect the developing brain and have lifelong consequences on physical and mental health in adulthood. By promoting, supporting, and educating everyone in Michigan we know we are helping to ensure a bright future for our state.

Each of the 73 CTF Local Council honors CAP Month in its own way. Pinwheel gardens spring up all across the state to bring awareness to the critical need for prevention work. The pinwheel is the national symbol of child abuse and neglect prevention. Some of the councils use April for sponsoring professional trainings, and/or interactive events for parents and children. Councils may also host a variety of fundraising events, raising much-needed dollars for the critical work they do. There is also an increased presence of newspaper articles, social media posts, and radio and television interviews all focusing on prevention during April.

To assist the CTF Local Councils with their CAP Month efforts a number of Local Councils have volunteered their valuable time for the past 8 years to participate in a sub-committee that helps plan the Children's Trust Fund's CAP Month programming and resources. This dynamic group includes: Catherine Martinez (Bay). Kathy Kelly (Ingham), Holly Naylor (Livingston), Miriana Milo (Oakland Co.), Leigh Moerdyke (Ottawa), Leslie Eschenbacher (Saginaw), and Cindy Swift (Out-Wayne). They are tasked with helping CTF develop a CAP Month toolkit, which provides high quality informational materials for CTF grantees, and other likeminded individuals and organizations for their own CAP Month use. This year marks the 9th annual Child Abuse Prevention Awareness Day (previously named Prevention Awareness Day) when we come together during Child Abuse Prevention (CAP) Month to acknowledge the issues of abuse and neglect in Michigan, recognize the great prevention work being accomplished in our state, and honor all our children and families. This rally event will be held on Thursday, April 27, 2017 at 11AM at the Lansing State Capitol steps. This event consists of a rally, procession, and the "planting" of a pinwheel garden. The rally portion features notable speakers and entertainment. Next, the procession will advance down Michigan Avenue toward the traffic circle at Michigan and Washington Avenue, where a pinwheel "garden" will be planted. The theme for this year's CAP Month is once more The Power of One. This statewide initiative under the leadership of the CTF asserts that the power of one person, one community, one dollar and one action can make a significant effect on the prevention of child abuse.

A Legislative Education Day (LED) component will be added to Prevention Awareness Day to afford CTF grantees and other child advocates an opportunity to educate legislators about prevention needs and current programming across the state.

CTF invites individuals and/or organizations to participate in this momentous rally event. Please attend the rally and visibly represent your organization, and/or come to educate legislators. If you receive Facebook notices about Prevention Awareness Day, we ask that you share the post (if you are able). How exciting it will be to see a great crowd at the Capitol to honor and celebrate our most precious legacy, the children of Michigan.

Your participation in Prevention Awareness Day will benefit you.


