MARATHON PETROLEUM COMPANY LP, DETROIT, WAYNE COUNTY, for the proposed draft Permit for the proposed installation and operation of a gasoil hydrotreater (GOHT) reactor, a GOHT feed heater, eight liquefied petroleum gas storage tanks, and a liquefied railcar load rack. The GOHT reactor and GOHT heater will allow the facility to produce gasoline that complies with the United States Environmental Protection Agency’s Tier 3 Fuel Standards. These standards will lower the amount of sulfur in gasoline, which will lower sulfur dioxide emissions from vehicles. The facility is located at 1300 South Fort Street, Detroit, Michigan. Additionally, installation and operation of a GOHT reactor, a GOHT feed heater, eight liquefied petroleum gas storage tanks, and a liquefied railcar load rack will require revisions to Renewable Operating Permit (ROP) No. MI-ROP-A931-2012b. The responsible official for the source is David Roland, 1330 South Fort Street, Detroit, Michigan. This public comment period meets the public participation requirements for a future administrative amendment to the ROP. The Water Resources Division will hold a public hearing Tuesday, December 15, 2015, at 6:30 p.m., at the Bedford Township Hall, 115 South Uldricks Drive, Battle Creek, Michigan 49017-1165. The applicant is seeking After the Fact Authorization for: 1) Dredging approximately 10 cubic yards of material from an area measuring 34 feet by 40 feet to a depth of 2 to 6 inches. The dredge material was pumped to an on-site upland area. 2) Construction of two permanent open pile docks. The western dock measures 24 feet long and 32 inches wide. It has an attached deck on the landward end with two attached sets of steps. The eastern dock measures 8 feet long and 32 inches wide. 3) Construction of a wood seawall approximately 28 feet long. The applicant is also seeking authorization to do additional regulated activities. These include: 1) Dredge an additional 150 cubic yards of material from an irregular shaped area measuring approximately 100 feet by 40 feet to a depth of 6 inches. The dredge material will be pumped to the same onsite upland area. 2) Construct approximately 60 feet of additional wooden seawall and place minimal seawall backfill as necessary. 3) Place approximately 3 cubic yards of clean rock as toe stone protection along the entire seawall. In Michigan facilities submit their emissions calculations through the Michigan Air Emissions Reporting System (MAERS). Maybe you know about MAERS, but have you ever wondered where that data goes and what it is used for? This webinar will give you a good idea of what happens after you click the submit button.

Sometimes a permit contains an emission limit for a specific air toxic, such as formaldehyde. Have you ever wondered why this happens?
