## NOTICE OF PUBLIC INFORMATION SESSION AND HEARING

The Michigan Department of Environmental Quality (MDEQ) is holding a coordinated public information session and hearing on October 24, 2018, from 6:00 P.M. to 8:00 P.M. (CDT) at Gogebic Community College Lindquist Student and Conference Center, Upper Level Conference Room, E-4946 Jackson Road, Ironwood, Michigan 49938 to hear testimony regarding the following proposed decisions:

- (1) The proposed decision to grant, with conditions, a request submitted by Copperwood Resources Inc. to amend Mining Permit MP 01 2012, issued under Part 632, Nonferrous Metallic Mineral Mining (Part 632), of the Natural Resources and Environmental Protection Act, 1994 PA 451, as amended (NREPA).
- (2) The proposed conditional approval of Permit to Install (PTI) Application Number 180-11A. It has been preliminarily determined that the installation of the copper mining and ore processing facility will not violate any of the MDEQ's rules nor the National Ambient Air Quality Standards.
