**SUBJECT: New Policy for Submitting Oil and Gas Records**

Effective January 1, 2012, the Office of Oil, Gas, and Minerals will changeover to a more simplified and centralized process for receiving oil and gas well drilling, completion, production, rework, and plugging records. After January 1, most well records can be submitted electronically in a digital format to a special email address or alternatively, paper records can be submitted by regular mail or courier to the OOGM office in Lansing. The record forms have been edited to reflect these new procedures.

There are three important points to remember: 1. When sending paper records, duplicate copies are not required, mail only the signed original to the appropriate Lansing or OOGM District Office as noted below. 2. Due to their file size, electric logs cannot be submitted by email. These should continue to be submitted to the Lansing office as previously required (paper copies and digital copies on a compact disk in TIF and LAS formats.) 3. Permit to drill and bond records are not covered by these new procedures. Permit applications and permit transfer request forms, applications for R303 spacing exception, well permittee organization reports, as well as all conformance bond forms must still be submitted on paper with original signatures.
