The Department of Environmental Quality (DEQ) requests comments on the Corrective Measures Implementation (CMI) Report submitted by General Electric Company (GE). The CMI Report documents work GE completed to address environmental contamination at the former General Electric Apparatus Service Center located at 18075 Krause Street, Riverview, Michigan.

GE submitted the CMI Report on August 13, 2018, and made subsequent revisions at the DEQ's request. GE was required to do this work under Part 111, Hazardous Waste Management, of the Natural Resources and Environmental Protection Act, 1994 PA 451, as amended (Act 451), and the federal Hazardous and Solid Waste Amendments to the Resource Conservation and Recovery Act of 1976.

The property is currently vacant. GE investigated soils and groundwater at the property. Results were compared to the non-residential criteria established under Part 201, Environmental Remediation, of Act 451, and the cleanup levels under the Toxic Substances Control Act, Title 40 of the Code of Federal Regulations Part 761. GE removed most soils contaminated by polychlorinated biphenyls, volatile organic compounds, and metals. Residual soil and groundwater will remain on-site. Evaluations show this contamination will not migrate off-site. A restrictive covenant will be placed on the property. It will limit property use to non-residential activities, identify locations where residual soil and groundwater remain, and identify the contaminants within those media.

The purpose of this notice is to give any interested party the opportunity to comment on the environmental work done at the property. Comments are due by 5:00 pm on December 21, 2018.

The DEQ has not scheduled a public hearing regarding the CMI Report. However, persons may submit a written request for a public hearing in accordance with Michigan Administrative Code R 299.9514. Written comments concerning the CMI Report should include the name and address of the writer, a concise statement of the basis for the comments, and the supporting relevant facts upon which the comments are based. Written comments must be postmarked by no later than December 21, 2018.

Before issuing a final decision, the DEQ will evaluate all comments received. Information regarding the final decision on the CMI Report will be communicated to all persons who submit written comments or who are on the facility mailing list. The DEQ will respond to all significant comments on the CMI Report and explain any changes made thereto.
