




High Risk Erosion Boundary and Breakpoint Descriptions
Oscoda Township, Iosco County*

The northern end of the high risk erosion area lies at the intersection of the Section 15-22 line, T24N, R9E, and the shoreline.

The southern end of the high risk erosion area in Section 22, T24N, R9E, lies 2,600 feet south of the intersection of the Section 15-22 line, T24N, R9E, and the shoreline.

The northern end of the high risk erosion area in Section 22, T24N, R9E, lies 1,765 feet north of the intersection of the Section 22-27 line, T24N, R9E, and the shoreline.

The southern end of the high risk erosion area in Section 22, T24N, R9E, lies 880 feet north of the intersection of the Section 22-27 line, T24N, R9E, and the shoreline.

The northern end of the high risk erosion area in Section 34, T24N, R9E, lies 2,100 feet north of the intersection of the Section 34, T24N, R9E, and Section 3, T23N, R9E, line and the shoreline.

The southern end of the high risk erosion area in Section 34, T24N, R9E, lies 955 feet north of the intersection of the Section 34, T24N, R9E, and Section 3, T23N, R9E, line and the shoreline.

*Note: These boundary descriptions are considered approximate. The exact locations of these boundaries are indicated on aerial photographs on file with the DNR.
