Flat River Watershed Planning Project

February 10, 2014 through March 31, 2017

The Flat River Watershed Management Plan lists prioritized Recommended Action Items for five different geographical areas in the 564 square mile watershed that drains into the Lower Grand River Watershed. It includes a compilation and assessment of new and existing chemical, physical, biological, and social watershed data. Sixteen Hydrologic Unit Code (HUC) 12's are listed as impaired by E. coli in the 2016 Integrated Report, and one HUC 12 has an E. coli TMDL. Other pollutants, including sediment, nutrients, increasing water temperatures, and altered hydrology impact the watershed. Generally, the goal of the Watershed Management Plan is to establish a strategy to manage the watershed as an asset that supports a diversity of native species, maximizes residents ability to use and enjoy the watershed, meets the water quality designates uses, and is aesthetically pleasing.
