SETTLEMENT AGREEMENT

In The Matter Of:

Camille and Danny Wheatley

License/Registration #: AM500297729, AS500256489

On June 10, 2014, the Bureau of Children and Adult Licensing (BCAL) issued a *Notice of Intent to Refuse to Renew* the adult foster care medium group home license of Camille and Danny Wheatley (#AM500297729). On June 10, 2014, BCAL also issued a *Notice of Intent to Revoke* Mr. and Mrs. Wheatley's adult foster care small group home license (#AS500256489).

In settlement of all issues raised in these notices of intent, the undersigned parties hereby agree:

- 1) Camille and Danny Wheatley have filed an appeal to the *Notice of Intent to Revoke*, making certain admissions and denials, but now accept the closure of their adult foster home licenses without further proceedings or factual determination.
- 2) Camille and Danny Wheatley understand that their adult foster care small group home license (#AS500256489) will be administratively closed, effective with the date of issuance of D & D Senior Living's adult foster care license for Shelby Manor 1 (#AS500364160).
- 3) Camille and Danny Wheatley understand that their adult foster care medium group home license (#AM500297729) will be administratively closed, effective with the date of issuance of D & D Senior Living's adult foster care license for Shelby Manor 2 (#AM500364162).
- 4) Camille and Danny Wheatley agree that Mr. Wheatley will move out of the residence located at 14184 22 Mile Road, Shelby Township, Michigan. Mr. Wheatley will vacate the residence at the adult foster care facilities no later than September 21, 2014.
- 5) Camille and Danny Wheatley understand that while their licenses remain active, Mr. Wheatley will not have any contact with residents at Shelby Manor I and Shelby Manor II.
- 6) Camille and Danny Wheatley have designated Deidre Wheatley to act as the administrator of their adult foster care facilities, Shelby Manor I and Shelby Manor II. Mr. Wheatley agrees that he is not acting as a staff member at Shelby

Manor I and II. Other than maintaining ownership of the property at 14184 22 Mile Road, Mr. Wheatley agrees not to have any involvement in the operation of Shelby Manor I and Shelby Manor II.

- 7) Camille and Danny Wheatley understand that if BCAL finds D & D Senior Living in substantial noncompliance with adult foster care licensing rules, BCAL may issue a *Notice of Intent to Deny* D & D Senior Living's applications for Shelby Manor 1 and Shelby Manor 2. Mr. and Mrs. Wheatley understand that their licenses will be administratively closed, effective with the date of issuance of the *Notice of Intent to Deny* D & D Senior Living's applications.
- 8) Camille and Danny Wheatley understand that they are waiving their right to appeal the *Notice of Intent to Refuse to Renew* and the *Notice of Intent to Revoke*, and an administrative hearing will not be held in this matter.
- 9) Camille and Danny Wheatley agree not to apply for a license for an adult foster care organization licensed under the Adult Foster Care Facility Licensing Act for a period of five years. Other than maintaining a financial interest as the property owners of 14184 22 Mile Road, Mr. and Mrs. Wheatley agree not to be connected with the operation of an adult foster care facility for a period of five years from the effective date of this agreement.
- 10) Camille and Danny Wheatley understand that any violation of the terms of this agreement may result in further disciplinary action of their adult foster care licenses.
