SETTLEMENT AGREEMENT

In The Matter Of:
Southfield Christian & Seminary Center
License #: DC630311503

On March 17, 2014, the Bureau of Children and Adult Licensing issued a *Notice of Intent to Revoke* the child care center license of and Southfield Christian & Seminary Center. In settlement of all issues raised in the *Notice of Intent to Revoke*, the undersigned parties hereby agree:

- 1) Abigail Slater and Southfield Christian & Seminary Center neither admit nor deny the allegations set forth in the *Notice of Intent to Revoke*; however, Ms. Slater and Southfield Christian & Seminary Center admit to a violation of the Child Care Organizations Act or a licensing rule promulgated under the Act.
- 2) Abigail Slater and Southfield Christian & Seminary Center understand that the child care center license will be revoked, effective the date of the signature by the representative of the Bureau of Children and Adult Licensing.
- 3) Abigail Slater and Southfield Christian & Seminary Center understand that it is unlawful to provide child care without a license. Abigail Slater and Southfield Christian & Seminary Center agree to cease providing child care at Southfield Christian & Seminary Center, or at any other unlicensed location.
- 4) Abigail Slater and Southfield Christian & Seminary Center understand that they are waiving their right to appeal the *Notice of Intent to Revoke* the license, and an administrative hearing will not be held in this matter.
- 5) Abigail Slater and Southfield Christian & Seminary Center agrees not to apply for an original license or certificate of registration for a child care organization licensed or registered under the Child Care Organizations Act for a period of two years, and agree not to be connected, directly or indirectly, with a licensee or registrant for a period of two years from the effective date of this agreement.
