

SETTLEMENT AGREEMENT


**In the Matter of:

On October 6, 2014, the Bureau of Children and Adult Licensing issued a licensing study report recommending refusal to renew for the child care center license of Bethel AME Church.

In settlement of all issues raised in that licensing study report, the undersigned parties hereby agree:

- 1) Bethel AME Church neither admits nor denies that the violations set forth in the licensing study report are true; however, Bethel AME Church admits that a violation of the Child Care Organizations Act or a licensing rule promulgated under the Act did occur.
- 2) Bethel AME Church does not contest the refused renewal of the license, effective October 24, 2014.
- 3) Bethel AME Church understands that it is unlawful to provide child care without a license and agrees to cease providing child care services after October 24, 2014.
- 4) Bethel AME Church understands that it is waiving its right to appeal the violations cited in the licensing study report, and an administrative hearing will not be held in this matter.
- 5) Bethel AME Church, Licensee Designee Phelmon Saunders, and Licensee Designee Karla Smith agree not to apply for a license or license for a Child Care Organization licensed or registered under the Child Care Organization Act for a period of two years from the effective date of this agreement.

- 6) This agreement does not prohibit Licensee Designee Karla Smith from working in a licensed child care organization so long as the position at the organization is not one of registrant, licensee, or licensee designee.


