Dear Senator Hardiman and Representative Spade:

Section 274 of 2009 Public Act No. 129 (Enrolled Senate Bill 248) requires the Michigan Department of Human Services (DHS) to report on “each federal grant this state was eligible to apply for, listing both grants applied for and not applied for FY 2010 [covering] grants exceeding \$500,000, related to fatherhood and marriage initiatives, teen pregnancy prevention, kinship care, before-and-after-school programs, family preservation and prevention, homeless prevention, and youth in transition.”

Please accept the attached spreadsheet extracted from departmental sources as our report for fiscal year 2010. The report shows the department’s activity concerning discretionary grants released from 26 federal agencies through grants.gov. Some highlights of these activities include:

- Four grant opportunities of \$500,000 or more met the Legislature’s interest.
- DHS applied for all four of these grants.
- Of these four applications, all are pending. (See attached spreadsheet for details.)
