

STIPULATION AND ORDER FOR PERMANENT INJUNCTION


STIPULATION

Pursuant to the parties' stipulation, and for the reasons stated on the record at the hearing on Plaintiff's motion for preliminary injunctive relief, the Court hereby ORDERS the following:

1. Defendant is permanently enjoined from directly or indirectly operating, owning, managing, or maintaining an Adult Foster Care (AFC) facility—as defined by the Adult Foster Care Facilities Licensing Act, MCL 400.701 *et seq.*—anywhere in the State of Michigan, including 7174 Martin Avenue S.E., Grand Rapids, MI 49548, without a valid license issued by the Department

2. The parties will bear their own costs and fees associated with this action.
