




The Michigan Administrative Hearing System has removed this case from its docket, and closed its file in this matter.







On July 8, 2014, the Bureau of Children and Adult Licensing issued a *Notice of Intent to Revoke* the adult foster care small group home license of Mozella's Home, Inc. Ozella Wingate is the Licensee Designee and Administrator of Mozella's Home, Inc., and therefore signs on behalf of the licensee corporation. In settlement of all issues raised in the *Notice of Intent to Revoke*, the undersigned parties hereby agree:

- 1) Mozella's Home, Inc. has filed an appeal to the *Notice of Intent to Revoke*, making certain admissions and denials, but now desires for its license to be closed without further proceedings or factual determination.
- 2) Ozella Wingate understands that the adult foster small group home license for Mozella's Home, Inc. will be administratively closed effective with the date of signature by the representative of the Bureau of Children and Adult Licensing.
- 3) Ozella Wingate, acting on behalf of Mozella's Home, Inc., understands that an administrative hearing will not be held in this matter.
- 4) Mozella's Home, Inc. will not expand its business by applying for an original license of a new adult foster care organization licensed under the Adult Foster Care Facility Licensing Act for a period of three years.
- 5) Other than those facilities currently licensed, Mozella's Home, Inc. and its agents will not be connected, directly or indirectly, with a licensee for a period of three years from the effective date of this agreement. This agreement does not affect the license for Richton Home, Inc. (License #AM820338943).
