


SETTLEMENT AGREEMENT


- 1) Stoepel Manor, LLC neither admits nor denies that the specific allegations set forth in the *Notice of Intent to Revoke* are true.
- 2) Stoepel Manor, LLC agrees to the administrative closure of its adult foster care small group home license.
- 3) Stoepel Manor, LLC understands that the administrative closure of its adult foster care small group home license will be effective the date of the signature by the representative of the Bureau of Children and Adult Licensing.
- 4) Stoepel Manor, LLC understands that it is waiving its right to contest the allegations set forth in the *Notice of Intent to Revoke* and an administrative hearing will not be held in this matter.
- 5) Stoepel Manor, LLC understands that due to the November 25, 2014, revocation of Strathmoor Manor, license number AS820284341, and pursuant to MCL 400713(10)(11), Bartholomew Ajulufoh cannot apply for a license for an adult foster care facility licensed under the Adult Foster Care Facility Licensing Act or have a relationship with a license until November 24, 2019.
