Section 677(2) of 2014 Public Act No. 252 requires the Department of Human Services (DHS) to report the following information on a monthly basis:

- 2. Current percentage of FIP cases involved in PATH employment activity.
- 3. Current percentage of FIP cases that meet federal work participation requirements.
- Current percentage of the FIP cases that meet federal work participation requirements for those referred to PATH.

1. Number of cases referred to PATH:

The number of Family Independence Program (FIP) cases referred to PATH for December 2014 was <u>52,342</u>. Source: One Stop Management Information System (OSMIS) data as of February 3, 2015.

2. Current percentage of FIP cases involved in PATH employment activities:

The percentage of Family Independence Program (FIP) cases "involved in PATH employment activities" for December 2014 was 67.5% The table below provides a breakdown of participants coded as "Work First" and includes all FIP recipients (federal and state-funded) who attended orientation and started an activity.

3. Current percentage of FIP cases that meet federal work participation requirement.

The current percentage of FIP cases that meet federal work participation requirements for FY 2015, year-to-date (October 2014) is <u>62.15</u>% as of February 9, 2015. FIP work participation rates are point-in-time rates subject to change based on receipt of verifications and review by the Department of Health and Human Services, Administration for Children and Families. The work participation rate is calculated by the DHS Office of Quality Assurance and Internal Control.

4. Current percentage of the FIP cases that meet the federal work participation requirement for those referred to PATH.

Of the 62.15% of FIP cases that meet the federal work participation requirement for FY 15, year-to-date (October 2014), 76.56% of the cases were referred to PATH.

<u>Please Note:</u> The following table provides details regarding the data included for each monthly report for Fiscal Year 2015. The DHS Office of Quality Assurance and Internal Control reports Work Participation Rate (WPR) data for #3 and #4 on a 3-month lag because of the rigorous methodology and testing required to calculate the data.
