Dear Senator MacGregor and Representative Poleski:

Section 275(2) of 2014 Public Act 252 requires the Department of Human Services (DHS) to provide information on administrative savings achieved through changes in staffing as required under Section 275(1). Please see the attached information indicating the cumulative number of positions impacted year to date. While no additional positions have been abolished or held vacant since our previous report, the department has begun to implement a reduction in force that will result in additional positions being abolished in mid-February. DHS anticipates approximately 100 people will be laid off as a result of this action, although the department is working to identify other positions that may be available for these affected individuals. The department will provide an updated estimate of the total positions ultimately impacted by these efforts in the coming months, along with a projected total savings as these actions are completed.
