Dear Senator Caswell and Representative MacGregor:

Section 275(2) of 2013 Public Act 59 requires the Department of Human Services (DHS) to provide information on administrative savings achieved through changes in staffing as required under Section 275(1). Please see the attached information indicating the cumulative number of positions impacted year to date; no additional positions were abolished or held vacant during this reporting period. Based on the positions held vacant or abolished to date, the department estimates a total cumulative savings of \$6.6 million gross, \$3.0 million general fund. As required under section 275(3) of 2013 Public Act 59, the department will submit a request at year-end transferring the savings to the identified budgetary line item.
