SETTLEMENT AGREEMENT

In The Matter Of:  
VFW National Home

On September 25, 2014, the Bureau of Children and Adult Licensing issued its final *Special Investigation Report* recommending disciplinary action of the child caring institution license of VFW National Home. Patrice Green is the Administrator of VFW National Home and therefore signs on behalf of the licensee corporation. In settlement of all issues raised in the *Special Investigation Report*, the undersigned parties hereby agree:

- 1) VFW National Home neither admits nor denies the allegations set forth in the *Special Investigation Report*, but admits there has been a violation of R 400.4137.
- 2) VFW National Home understands that VFW National Home's license will be administratively closed, effective with the date of signature by the representative of the Bureau of Children and Adult Licensing.
- 3) VFW National Home understands that an administrative hearing will not be held regarding the closure of its license to operate a child caring institution.
- 4) This agreement does not limit VFW National Home's ability to respond to the allegations and content of the *Special Investigation Report*.
- 5) VFW National Home agrees not to apply for a license or certificate of registration for a Child Care Organization licensed or registered under the Child Care Organizations Act for a period of two years, and agrees not to be connected, directly or indirectly, with a licensee or registrant for a period of two years effective from the date Patrice Green signs this agreement.
- 6) This agreement does not affect VFW National Home's license to operate VFW Ladies Auxiliary Nursery child care center (License #DC330020400) or to engage Patrice Green or any other person to work at or provide administrative services to VFW Ladies Auxiliary Nursery child care center.
