The percentage of Family Independence Program (FIP) cases "involved in JET employment activities" for March of 2013 was **55.5%**. 2. Current percentage of FIP cases that meet federal work participation requirement.

The current percentage of FIP cases that meet federal work participation requirements for FY 2013, year-to-date (October 2012 - January 2013) is **48.70%**. This percentage is calculated by the DHS Office of Quality Assurance.

The DHS Office of Quality Assurance reports work participation rates (WPR) on a 3 month lag because of the rigorous methodology and testing required to calculate the data for federal reporting purposes.
