

FINAL ORDER TO CEASE AND DESIST

1. On March 12, 2018, the Chief Deputy Director issued an Order to Cease and Desist (Order) pursuant to Section 251 of the Michigan Insurance Code (Code), MCL 500.251, against Respondent Donna Bankston. The copy of the Order is attached to this Final Order to Cease and Desist.
2. The Order contained allegations that Respondent violated MCL 500.1201a(1), MCL 500.1208a(1), and MCL 500.1240(2) of the Code. Respondent was found to be advertising and attempting to sell automobile insurance without a license.
3. On March 13, 2018, the Order was mailed to Respondent via first class and certified mail to the last known address of record. The mail was returned by the United States Post Office after an attempt to deliver the mail was unsuccessful due to the addressee not being known at the place of delivery.
4. On April 9, 2018, the Order was mailed to Respondent via first class and certified mail to an alternative address of record, located during a new address search. The mail was returned by the United States Post Office as "undeliverable as addressed – unable to forward."
5. Having made reasonable attempts to serve the Respondent in this matter, the Order is now **FINAL and, as ordered:**
 1. The Respondent shall immediately **CEASE AND DESIST** from all activities in violation of the Code as described in the Statement of Findings.
 2. A copy of this Order shall be immediately served upon Respondent. As to any Respondent, this Order shall be effective upon the date of service.
 3. The Director retains jurisdiction of the matters contained herein and the authority to issue such further Orders as shall be deemed just, necessary, and appropriate.

4. Pursuant to Section 251(6) of the Code, MCL 500.251(6), a person who violates or otherwise fails to comply with an Order to Cease and Desist is subject to one or more of the following:
 - a. Payment of a civil fine of not more than \$1,000 for each violation not to exceed an aggregate civil fine of \$30,000. However, if the person knew or reasonably should have known the conduct was in violation of the cease and desist order, the person shall be subject to a civil fine of not more than \$25,000 for each violation not to exceed an aggregate civil fine of \$250,000.
 - b. Suspension or revocation of the person's license or certificate of authority.
5. Complete restitution, in the form, amount, and within the period determined by the Director, to all persons in Michigan damaged by the violation or failure to comply.
