## MEMORANDUM TO THE NATURAL RESOURCES COMMISSION

Subject:

Antlerless Deer License Quotas in the Upper Peninsula

Wildlife Conservation Order Amendment No. 6 of 2019

## Authority:

The Natural Resources and Environmental Protection Act, 1994 PA 451, authorizes the Director and the Commission to issue orders to manage wild animals in this state.

## Discussion and Background:

Since the harsh winters of 2013 and 2014 which had an impact on the Upper Peninsula (UP) deer herd, the Department has seen recovery in the deer herd as evidenced by increasing harvest and hunter success rates. In the southern UP, the Department is observing the highest densities of deer with the highest harvest levels anywhere on the Peninsula. With the recent detection of chronic wasting disease (CWD) in Dickinson County, and the recovering deer numbers in that area, the Department recommends additional opportunities for hunters to manage the local deer herd.

For the 2019 deer hunting season, the Department recommends a moderate liberalization of antlerless harvest opportunity as originally recommended by the Department in 2018. This includes:

- Reopening Deer Management Unit (DMU) 022 to antlerless license issuance.
- Increasing antlerless license quotas, as shown below, for public and private land licenses in each DMU.
  - Increasing antlerless licenses available in DMU 022 to 200 public land and 500 private land for a total of 700.
  - o Increasing antlerless licenses available in DMU 055 to 1,000 public land and 7,000 private land for a total of 8,000.
  - o Increasing antlerless licenses available in DMU 121 to 400 public land and 800 private land for a total of 1,200.
  - Increasing antlerless licenses available in DMU 122 to 200 public land and 1,000 private land for a total of 1,200.

- o Increasing antlerless licenses available in DMU 155 to 300 public land and 1,800 private land for a total of 2,100.
- o Increasing antlerless licenses available in DMU 255 to 500 public land and 1,000 private land for a total of 1,500.

### Issues Pros and Cons

In October 2018, a 4-year old doe harvested on a deer damage shooting permit in Waucedah Township, Dickinson County tested positive for CWD. The Department took immediate action and increased testing and active surveillance to better understand where the disease exists. The Department set up a surveillance area, centered on Waucedah Township, and set a goal to test a minimum of 600 deer to better determine the extent of possibly infected deer. In 2018, the Department tested 1,745 deer from the surveillance area and to date has not found any additional positives. The recommendation to increase antlerless license quotas in the select DMUs in the UP supports continued aggressive CWD surveillance and deer management.

## Biological

Antlerless harvest was highly restricted in the UP during the 2014-16 regulation cycle due to a 3-year span of harsh winters. Only three DMUs were open to antlerless license issuance, and quotas were conservative. Deer numbers in the UP began to rebound by spring 2017 following two consecutive mild winters. Antlerless harvest opportunity was expanded to five DMUs, and antlerless license quotas were increased. With the discovery of CWD in the southern UP, which appears to be in an early stage based on current surveillance, the Department believes that management of the deer population is important in slowing the spread of the disease to new areas.

### Social

Commercial forest managers and The Society of American Foresters have requested new or liberalized tools to address deer browsing impacts to forest regeneration.

The UP CWD Task Force met on March 21, 2019, and drafted recommendations to the Department and the Natural Resources Commission, suggesting measures taken in the UP should

differ from those implemented in the Lower Peninsula, based on a variety of differences including geography and deer-herd dynamics. The UP CWD Task Force supports increased quotas in the southern UP.

## Economic

The number of deer harvested by farmers this past summer on deer damage shooting permits to protect their crops from damage in the south-central UP reached a 5-year high. Antlerless harvest opportunities continue to be important to address agricultural damage and forest regeneration concerns.

## **Technical Change**

The Department recommends a technical change to DMU 122 public land antlerless deer licenses. The public land antlerless deer license quota for DMU 122 is 100 licenses; however, the Wildlife Conservation Order lists DMU 122 as closed to public land antlerless deer licenses. The Department recommends correcting this oversight by opening up DMU 122 to public land antlerless deer licenses.

# **WILDLIFE CONSERVATION ORDER**

## Amendment No. 6 of 2019

By authority conferred on the Natural Resources Commission and the Director of the Department of Natural Resources by sections 40107 and 40113a of 1994 PA 451, MCL 324.40107 and 324.40113a, it is ordered that effective June 14, 2019, the following section(s) of the Wildlife Conservation Order shall read as follows:

## 3.105 Antlerless-only license quotas.

Sec. 3.105 (1) The director in consultation with and concurrence with the natural resources commission may make appropriate minor changes to antierless deer quotas established in 3.105(2) to meet disease control, population goal, or other management objectives.

(2) Notwithstanding any other provision of this section, the antlerless deer license quotas are as shown in table 3:







Comments:

The Thompson State Fish Hatchery (TSFH) is undergoing a significant renovation and expansion to increase cool water fish production in the state. The new cool water facility is located on TSFH property, south of the existing facility, which minimizes impacts to wetlands and balances the land by maximizing the use of existing on-site soils without the need to bring in additional fill. The new facility will impact approximately six acres of previously disturbed scrub-shrub and forested wetlands.

Under Part 303 of the NREPA, the Department of Natural Resources (Department) is required to mitigate for the loss to any wetlands. The proposal is to place 120 acres of wooded dune swale wetland complex into permanent preservation. This land is administered by the Fisheries Division and is contiguous to the project site on land to the east. The area contains several threatened and endangered species and a vulnerable wetland type. The site is currently not actively managed, is under threat of off-road vehicle use, and has the presence of invasive species.

Under the wetland rules, EGLE requires a conservation easement on the property. The easement requires that the land be managed to reduce the threat of invasives and limit activities which can create permanent damage to the threatened and endangered species on the site. Mitigation also requires an endowment or funding to be in place for permanent long-term management of the preservation area.


