We will start the day with safety orientation and then target practice with one on one instruction-target ammo will be provided by Federal Ammunition. Extra attention and instruction for those who have never bird hunted before - Beginners are welcome!

Lunch will be served in the dining room with your menu choice. After lunch, we will break up into small groups and head out to the field for a guided walk-up hunt with dogs!

**Hunter orange as your outermost clothing is required by law.**

Please indicate on the registration form if you need to borrow a shotgun. We have several 20 gauge shotguns for your use. We also have hunter orange vests for your use. Eye and ear protection for target practice will also be provided.

Please bring (1) box of shotgun shells – field load for the hunt in the afternoon. Your target ammunition is donated by Federal Ammunition. For your convenience, ammunition is available for purchase at the Hunters Creek Pro Shop.

Please note: hunting license and guide gratuities are not included in the registration fee. As required by law, birds must be cleaned by Hunters Creek staff. You may not take birds with you that are not cleaned.
