Eliminate Sunset on Extended Archery Season in Wayne, Oakland, and Macomb

- Would keep archery season in these three counties through January 31
 - Rest of state ends on January 1
 - Pilot originally established in 2017 to afford opportunities for communities to participate in managed archery hunts



Expanded Archery Season Results (3 County Area)


Statewide Hunters:

45% supported expanded archery 16% opposed expanded archery 48% Uncertain (Unsure + Neither Support/Oppose)

SE LP Hunters:

61% supported expanded archery 14% opposed expanded archery 24% Uncertain (Unsure + Neither Support/Oppose)





Initiation of Harvest Registration beginning in 2021

- Beginning in 2021, the Department will begin accepting deer for harvest registration voluntarily through an online registration system
- No regulatory changes needed at this time
- Plan is to move to mandatory registration for 2022 season



Why Voluntary Registration the First Year?

- Allows the Department to test the system to ensure it's in proper working order
- Expanded communication
- Increased hunter familiarity
- Incorporate feedback from hunters after testing the system








Universal Antlerless License


- Antlerless license that can be utilized across multiple DMUs
- Is less restrictive and offers more flexibility
- Currently a complex antlerless drawing for over 100 DMU designations
 - 55 of 58 Lower Peninsula DMUs showing stable or increasing deer trends
 - 0 Lower Peninsula DMUs desiring increasing deer trends

Antlerless License Use Framework




- One antlerless license type
 - Available to be used on any property in open units
 - Limited drawzones in UP




Antlerless License Use-Upper Peninsula


- Limited drawing for East UP and West UP
 - Successful hunters have accompanying deer hunting access permit that authorizes antlerless license use in that specific zone













Late Season Crossbow Use in the UP

- Crossbows added to archery season throughout state in 2009
- Excluded in late season of Upper
 Peninsula due to concerns from hunters
- Crossbows added to late season in UP Core CWD Surveillance Area in 2019







Pre and Post Crossbow Legalization Estimated Antlerless/Antlered Harvest Statewide




Pre and Post Crossbow Legalization Estimated Antlerless/Antlered Harvest in the UP



Elimination of Hunter's Choice in the UP

- Hunter's Choice initiated in UP in 2009
 - Applies a 3 point APR to regular tag of Combination License
 - Hunter's opt to hunt under APR's or not by deciding which license they purchase
- Drummond Island APR to remain in place








Elimination of Hunter's Choice in the UP

- Lack of consistency between license types
- Lack of impact on resource





Supplemental and Recreational Feeding

- Recreational Feeding
 - Placement of feed (2 gallons) within 100 yards of residence to attract deer for viewing
- Supplemental Feeding
 - Placement of larger feed quantities to aid in winter deer survival



Issues

Enforcement

 Inconsistencies between recreational and supplemental feeding cause confusion and enforcement problems

Safety

 Feeding situations can be dangerous due to causing deer/vehicle collisions or people being too close to wildlife (feeding near schools)

Lack of Consistency

- Supplemental feeding does not have a start date only an end date
- Different stipulations within each feeding type

Issues

- Lack of Clarity
 - Residents put out 2 gallons and when it's gone within an hour, they put two more gallons out, etc. multiple times a day
 - Not the intent of recreational feeding

 moves to a supplemental feeding situation
- Lack of educational materials/opportunities
 - Staff have a desire to work more on educational materials regarding feeding of deer, specifically on:
 - Risks associated with feeding
 - Proper feed types and distribution to minimize risk



Recommended Solutions

- Worked with Law Enforcement Division to develop the following:
 - Address safety concerns
 - Add "Recreational feeding and supplemental feeding may be prohibited if a location is deemed to be a hazard."
 - Add in language to recreational feeding that a person cannot utilize the feed as bait nor hunt over it
 - Change recreational feeding to only allow 2 gallons per calendar day and only 2 gallons at any one time.



Recommended Solutions


- Worked with Law Enforcement Division to develop the following:
 - Supplemental feeding cannot occur before
 January 1 and cannot extend beyond May 15
 - Eliminate supplemental feeding permit
 - Focus on educational opportunities for the public through staff engagement and outreach materials



Antlerless Options for Archers in the UP

- 2 amendments passed this summer
 - Closed to antlerless harvest in select DMUs in the west UP
 - Set guidelines for closing antlerless harvest in DMUs when 100 days of 12" of snow have been observed in previous DMUs
 - Deemed unenforceable by DNR legal
- Department recommends removing these changes to allow antlerless opportunities for archers across the UP
