

Fisheries Regulations Review

- Historically: 50 Fisheries Orders
- Consolidated to 30 since 2008
- Since 2011: ~ 460 regulation changes
- 70% provided additional angling opportunities
- 2-year guide & regulation process failed



F.O. 200: MH 2 update

- Angler catch information: January
- Model regulations and meet with constituents in February
- Develop report/recommendations for March NRC meeting
- If required, Information item April, Action in May

2018 Late Elk Season Summary

- Hunt Period 2:
 - December 15-23
- Weather was favorable
 - Favorable conditions with slightly less snowfall than normal.

- License Quota: 100
- 30 any elk
- 70 antlerless only elk




Elk Harvest – Late Season






- 30 antlered bulls
- 37 cows
- 11 calves
- 83% success (94 hunters)
- Three illegal takes (2 bulls taken on antlerless tags, one cow taken on private land w/out permission)
- Tribal harvest: 13 elk
 - 4 bulls, 9 cows/calves






Early Hunt Harvest Map






Late Hunt Harvest Map










2017 Total Elk Season Summary

- Hunt Period 1 Harvest:
 - State hunter harvest: 69 legally harvested elk
 - 28 bulls, 41 cows/calves; 69% success
- Hunt Period 2 Harvest:
 - State hunter harvest: 78 legally harvested elk
 - 30 bulls, 48 cows/calves; 83% success
- Tribal Harvest: 16 elk
- All 3 Pure Michigan hunters successful

Beaver Island Feeding Exception

Background

- Per WCO 3.100 (a)
 - Effective January 31, 2019, it shall be unlawful for a person to engage in deer and elk feeding within zone 2 and zone 3.

 Request from Beaver Island Wildlife Club for an exception to allow recreational feeding



CWD Status on Beaver Island

- Not detected
 - 2015-2016- 0 samples received
 - 2017- 1 sample received
 - 2018- 21 samples received

 Commitment from BIWC to continue testing deer if exemption is applied



Surveillance

- No population level data from Beaver Island
- Harvest approximately 100 deer (+/- 20)
- For testing with 95% confidence:

Prevalence

Population	0.5%	3.0%	10%
1,000	460	97	31
