## NOTICE

The Department of Natural Resources (DNR) anticipates offering nominated minerals at a proposed October 29, 2014, Oil and Gas Lease Auction. All nominations must meet the following criteria:

- Nominations must be received on *Oil and Gas Lease Auction Nomination* form PR4303.
- Nominator must provide the total acres nominated.
- Nominator must include the surface owner's name, address, and specific legal description on parcels where the DNR owns the minerals ONLY. Please type the specific legal description of each surface owner on the form OR highlight and enclose the specific information on equalization documents. Failure to provide accurate surface owner information may result in the withdrawal of that parcel from the nomination. No refund of the nomination fee will be issued.
- In order for minerals to be considered for the auction, Minerals Management (MM) must receive the nomination form, appropriate fee, and surface owner information between May 5 and June 6, 2014. Please do not wait until the final day to submit your nominations. Nominations will be accepted during the referenced time period only.
- Only the first 125,000 acres nominated will be field reviewed for parcel classification prior to being considered for leasing. Any leases offered for parcels which were nominated after the first 125,000 acres will be offered as Nondevelopment leases.
- Only DNR-managed or previously leased minerals will be included in the auction. Mineral rights owned by other state departments may only be leased through the Direct Lease process, if applicable.
- If nominating parcels containing state-owned minerals within a subdivision, you must provide the subdivision name, lot, and block number. Please note, some nominated subdivision parcels may require additional research and may not be included in the upcoming auction. In this instance, the parcels will be included with the nominations for a subsequent auction.

Nominations that do not meet the above criteria may not be included in the proposed October 29, 2014 auction. No refunds of nomination fees will be given. Nominations will be processed in the order received during the nomination period.

**REMINDER:** A nomination does not guarantee that each parcel will be offered. Other factors may impact the ability to lease the minerals (e.g., surface use considerations, title issues, existing lease on the parcel, or Executive Order). The MM staff will make every attempt to include eligible nominated parcels in an upcoming auction. No refund of nomination fees will be made if it is determined the minerals cannot be offered for lease.
