INSTRUCTIONS: Under the Michigan Natural Resources Trust Fund (MNRTF) program, applications for acquisition of land or rights in land may be accepted for public outdoor recreation and/or natural resource conservation purposes. If you represent a unit of government authorized to provide public, outdoor recreation (state agency, county, city, village or township), this form enables you to have your acquisition request considered by the MNRTF board at any time of the year (out-of-cycle). However, the proposed acquisition proposal must meet the following criteria: 1) Has regional impact, 2) Provides for the conservation of, or access to, significant natural resources, or public outdoor recreation opportunities, and 3) Has an estimated market value of \$1 million or greater. Exceptions may be made to these guidelines at the discretion of the Department and Board.
