Dear Senator McManus and Representative Lahti:

Pursuant to Section 1401, PA 118 of 2009, the Department of Natural Resources is required to report on amounts appropriated, based on federal pass-through funds received in excess of the original amount appropriated for Grants to communities – federal oil, gas, and timber payments, where additional state matching funds are not required. For Fiscal Year 2008-2009, \$1,318,768 of additional authority was provided to the Grants to communities – federal oil, gas, and timber payments line item, based on federal pass-through revenue received in excess of the original amount appropriated (\$1,175,121 of federal Department of Agriculture authority, based on excess timber pass-through revenue, and \$143,647 of federal Department of Interior authority, based on excess mineral revenue). No state matching funds were required for the additional federal authority, which was provided pursuant to Section 1101, PA 252 of 2008.
