Dear Senators Birkholz and McManus and Representatives Sheltroun and Lahti:

Pursuant to Section 74117, PA 451 of 1994, the table below summarizes the Department of Natural Resources (DNR) Fiscal Year 2006-2007 revenue stream from state parks motor vehicle permit fees. The state parks system did not receive any General Fund/General Purpose revenue in Fiscal Year 2006-2007, and the Michigan State Parks Endowment Fund was not impacted by the motor vehicle permit revenue stream.
