Pursuant to Section 1907a(1) of PA 451 of 1994, as amended, the Department of Natural Resources (DNR) is required to prepare a bimonthly report on the status of property that has yet to be acquired or developed in the manner approved by the Michigan Natural Resources Trust Fund (MNRTF) Board and is not open to public use within two years after spending authorization is provided by the Legislature.
